**Sub: Intimation of Record Date for payment of Final Dividend on equity shares of the Company for the financial year 2025-26**

In reference to our earlier intimation dated May 07, 2026, it was informed that the Board of Directors of the Company at its meeting held on May 07, 2026, had recommended Final Dividend of Rs. 18/- per equity share of the face value of Rs. 10/- each for financial year 2025-26 (i.e. 180%), subject to the approval of shareholders at the ensuing Annual General Meeting ('AGM'), which is scheduled to be held on **Tuesday, August 25, 2026**.

The Final Dividend, if approved by shareholders at the ensuing AGM, will be paid subject to the deduction of tax at source at applicable rates, within 30 days from the date of AGM, to those Members / Beneficial Owners, whose names appears in Register of Members of the Company / Register of Beneficial Owners maintained by the Depositories, on closure of business hours as on Record Date.
