This Joint Venture shall be operational through incorporation of a new joint venture entity in India by Spark Minda Green Mobility Systems Private Limited.

Upon closing, the shareholding of the proposed JV company shall be 49% held by Spark Minda Green Mobility Systems Private Limited, India, and 51% held by Turntide Drives Limited, United Kingdom.
