Sub: Consolidated Scrutinizer's Report on the voting made through e-voting system in the meeting of Equity Shareholders of Mirza International Ltd as well as through remote e-voting process before the meeting, for approval of the Scheme, inter-alia, for (a) Amalgamation of RTS Fashions PVT Ltd with Mirza International Ltd and (b) De-merger of Branded business/Redtape Business of Mirza International Ltd into Redtape Ltd

Respected Sir/Madam

I, Anil Kumar Mittal, having my residence at 5/99, Sector-2, Rajender Nagar, Sahibabad, Ghaziabad-201005, appointed by the Hon'ble National Company Law Tribunal, Allahabad Bench, Prayagraj [in the CA (CAA) No. 11/ALD/2022], vide its Order dated 14th June, 2022 (date of pronouncement), to act as the Scrutinizer for ascertaining the result of voting in the meeting of Equity Shareholders of Mirza International Ltd (hereinafter referred to as "the Transferee Company/the Company") held on Saturday, 6th August, 2022, at 11:00 A.M. through video conferencing, to consider and, if thought fit, approve, the Composite Scheme of Arrangement of RTS Fashions Pvt Ltd, Mirza International Ltd and Redtape Ltd (the Scheme of Arrangement/the Scheme) and other connected matter, if any, submit my report as under:

The compliance with the provisions of the Companies Act, 2013, rules made thereunder, applicable NCLT rules and NCLT Order dated 14.06.2022 relating to voting on the resolution contained in the notice, are the responsibility of the Management of the company. My responsibility as scrutiniser is to ensure that the voting process is conducted in a fair and transparent manner and to make a Scrutiniser's report, being the report of the total votes cast "**in favour**" and "**against**" on the said resolution, based on polling records/ reports generated, since the voting is conducted through e-voting.

I do hereby, submit my report as under:

1. That as directed by this Hon'ble Tribunal, the meeting of the Equity Shareholders of Mirza International Ltd was duly convened and held on Saturday, 6th August, 2022, at 11:00 A.M. through video conferencing. Mrs Santosh Kumari, Advocate, chaired the meeting. The undersigned being the Scrutinizer of the meeting, attended the meeting through




video conferencing. Legal Counsel of the Applicant Company-Mr Rajeev K Goel, Advocate and the senior management of the Applicant Company were also present in the meeting through video conferencing.

2. That National Securities Depository Limited (NSDL) was appointed to conduct remote e-voting before the meeting as well as during the meeting, in a secured manner. Whereas Mas Services Ltd, a SEBI registered Registrar and Transfer Agent (RTA) was appointed to provide platform for convening the meeting through Video Conferencing; to handle and supervise the entire process of holding the meeting through Video Conferencing, e-voting and processing of data relating to the meeting and voting, etc.

As per SEBI circular No. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 09.12.2020, all the DEMAT account holders are enabled for e-voting, by way of a single login credential, through their DEMAT accounts/ websites of Depositories/ Depository Participants. DEMAT account holders will be able to cast their vote without having to register again with the e-voting service providers (ESPs). This will facilitate seamless authentication. Copy of the aforesaid SEBI circular is attached herewith and marked as **Annexure: 1.**

Executives of Mas Services Ltd provided all the necessary support in connection with the convening, holding and conducting of the meeting and e-voting. The RTA handled and supervised the entire process of holding the meeting through video conferencing, e-voting and processing of data relating to the meeting and voting, etc.

3. As on 30th July, 2022, the Transferee Company had around 68,174 Equity Shareholders, as per details shared by the Company.
4. Notice of the meeting was sent to the Equity Shareholders of Mirza International Ltd accompanied by the Explanatory Statement [under Sections 230 & 232 of the Companies Act, 2013, read with Sections 66 and 102 of the Companies Act, 2013 and the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016, and other applicable provisions, if any], the proposed Scheme of Arrangement along with other documents, through E-mail on 1st July, 2022; and by advertisement published in "Business Standard" (English, Lucknow Edition) on 2nd July, 2022 and "Business Standard" (Hindi, Lucknow Edition) Newspaper on 2nd July, 2022. Further, MAS Services Ltd, the



Registrar and Transfer Agents (RTA) has, vide certificate dated 08.07.2022 have certified that e-mails of notice were sent to 63,624 Equity Shareholders, out of which 61,385 emails were delivered.

The Applicant Companies have already filed the requisite Compliance Affidavit of Service with this Hon'ble Tribunal on 15th July, 2022 vide diary no. 0902109003962022/3.

5. As per the instructions of the Chairperson, voting upon the Scheme of Arrangement was conducted through e-voting system in the meeting of Equity Shareholders of Mirza International Ltd (the Transferee Company) held through video conferencing.
6. On conclusion of the voting, complete detail of the e-voting made by the Equity Shareholders of the Company in the meeting was provided to me by NSDL.
7. The Company has also provided facility of remote e-voting during the prescribed time period before the meeting (without attending the meeting); in addition to the facility of attending the meeting through video conferencing and voting thereat through e-voting system. As per Rule 20(4)(vi) of the Companies (Management and Administration) Rules, 2014 which provides for voting through electronic means:

"the facility for remote e-voting shall remain open for not less than three days and shall close at 5:00 p.m. on the date preceding the date of the General Meeting."

Remote e-voting period commenced on 2nd August, 2022 at 9:00 A.M. and ended on 5th August, 2022 at 5:00 P.M. Complete details of the remote e-voting made by the Equity Shareholders of the Company was provided to me by the NSDL.

8. No vote was found to be invalid.
9. The result of the voting upon the Scheme of Arrangement (by way of voting through e-voting system in the meeting as well as through remote e-voting process before the meeting) is given as under:



Dear Sir/Madam,

Sub: e-Voting Facility Provided by Listed Entities

1. Under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level.
2. Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.
3. In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process. The same shall be implemented in a phased manner as under:


Phase – 1

Following process for e-voting shall be implemented within 6 months of the date of the circular.

- 3.1. Direct registration with Depositories – Shareholders can register directly with the depository. Shareholders would be able to access the e-voting page of various ESPs through the websites of the Depositories without further authentication by ESPs for participating in the e-voting process.

OR

- 3.2. Through Demat Accounts with Depository Participants – Demat account holders will have the option of accessing various ESP portals directly from their demat accounts.



They would be routed to the webpage of the respective Depositories from their demat accounts, which in turn would enable access to the e-voting portals of various ESPs without further authentication by ESPs for participating in the e-voting process.

4. The authentication of shareholders would happen at the depository level and ESPs shall allow the demat account holders to cast their vote based on the validation carried out by the Depository.
5. Depository shall send a confirmatory SMS to the shareholders that the vote has been cast based on the confirmation received from the ESP.
6. The listed entity shall provide the details of the upcoming AGMs requiring voting to the Depository. The depository shall send SMS/email alerts in this regard, to the demat account holders, atleast 2 days prior to the date of the commencement of e-voting.

Phase – 2

7. In order to further enhance the convenience and security of the e-voting system, the depository shall validate the demat account holder through a One Time Password (OTP) verification process as under.
 - 6.1 Direct registration with Depositories – Depositories shall allow login through registered Mobile number / E-mail based OTP verification as an alternate to login through username and password.
 - 6.2 Through Demat Accounts with Depository Participants – A second factor authentication using Mobile / E-mail based OTP shall be introduced before the demat account holders can access the websites of the Depositories through their demat accounts.

The above shall be implemented within 12 months from the completion of the process in phase 1.

- 7 Depository may advise the demat account holders to update their mobile number and email ID in order to access the e-voting facility.
- 8 Depositories shall establish a dedicated helpline to resolve technical difficulties faced by shareholders relating to the e-voting facility. Further, the listed company shall ensure that the ESPs engaged by them also provide a dedicated helpline in this regard.
- 9 In order to enable better deliberation and decision making by the shareholders while casting their votes, ESP Portals shall provide specific weblinks to the following:
 - disclosures by the company on the websites of the stock exchanges
 - report on the websites of the proxy advisors.




Applicability

- 10 The aforementioned facility shall be available to all individual shareholders holding the securities in demat mode.
- 11 ESPs may continue to provide the facility of e-voting as per the existing process to all physical shareholders and shareholders other than individuals viz. institutions/ corporate shareholders.
- 12 Depositories and Exchanges are advised to bring the circular to the notice of its Depository Participants and listed companies respectively.
- 13 All listed companies are advised to notify the above process available to demat account holders for e-voting in the notice sent to the shareholders.
- 14 This circular is being issued in exercise of powers conferred under Section 11 (1) of the Securities and Exchange Board of India Act, 1992 and shall be in addition to the provisions of the Companies Act, 2013.

I, Anil Kumar Mittal, having my residence at 5/99, Sector-2, Rajender Nagar, Sahibabad, Ghaziabad-201005, appointed by the Hon'ble National Company Law Tribunal, Allahabad Bench, Prayagraj [in the CA (CAA) No. 11/ALD/2022], vide its Order dated 14th June, 2022 (date of pronouncement), to act as the Scrutinizer for ascertaining the result of voting in the meeting of Un-secured Creditors of Mirza International Ltd (hereinafter referred to as "the Transferee Company/the Company") held on Saturday, 6th August, 2022, at 1:00 P.M. through video conferencing, to consider and, if thought fit, approve, the Composite Scheme of Arrangement of RTS Fashions Pvt Ltd, Mirza International Ltd and Redtape Ltd (the Scheme of Arrangement/the Scheme) and other connected matter, if any, submit my report as under:

The compliance with the provisions of the Companies Act, 2013, rules made thereunder, applicable NCLT rules and NCLT Order dated 14.06.2022 relating to voting on the resolution contained in the notice, are the responsibility of the Management of the company. My responsibility as scrutiniser is to ensure that the voting process is conducted in a fair and transparent manner and to make a Scrutiniser's report, being the report of the total votes cast "**in favour**" and "**against**" on the said resolution, based on polling records/ reports generated, since the voting is conducted through e-voting.

I do hereby, submit my report as under:

1. That as directed by this Hon'ble Tribunal, the meeting of the Un-secured Creditors of Mirza International Ltd was duly convened and held on Saturday, 6th August, 2022, at 1:00 P.M. through video conferencing. Dr Santosh Kumari, Advocate, chaired the meeting. The undersigned being the Scrutinizer of the meeting, attended the meeting through video




conferencing. Legal Counsel of the Applicant Company-Mr Rajeev K Goel, Advocate and the senior management of the Applicant Company were also present in the meeting through video conferencing.

2. That National Securities Depository Limited (NSDL) was appointed to conduct remote e-voting before the meeting as well as during the meeting, in a secured manner. Whereas Mas Services Ltd, a SEBI registered Registrar and Transfer Agent (RTA) was appointed to provide platform for convening the meeting through Video Conferencing; to handle and supervise the entire process of holding the meeting through Video Conferencing, e-voting and processing of data relating to the meeting and voting, etc.

Notice of the meeting was sent to the Un-secured Creditors of Mirza International Ltd accompanied by the Explanatory Statement [under Sections 230 & 232 of the Companies Act, 2013, read with Sections 66 and 102 of the Companies Act, 2013 and the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016, and other applicable provisions, if any], the proposed Scheme of Arrangement along with other documents, through E-mail on 1st July, 2022; and by advertisement published in "Business Standard" (English, Lucknow Edition) on 2nd July, 2022 and "Business Standard" (Hindi, Lucknow Edition) Newspaper on 2nd July, 2022. Further, MAS Services Ltd, the Registrar and Transfer Agents (RTA) has, vide certificate dated 08.07.2022 have certified that e-mails of notice were sent to 900 Un-secured Creditors, out of which 895 emails were delivered.

The Applicant Companies have already filed the requisite Compliance Affidavit of Service with this Hon'ble Tribunal on 15th July, 2022 vide diary no. 0902109003962022/3.


