अभिनेता प्रभासचा आदिपुरुष २० हजार स्क्रीनवर होणार रिलीज



हिंदी चित्रपट क्षेत्रात कमाईमध्ये अव्वल ठरलेल्या दक्षिणात्य अभिनेता प्रभासच्या बाहुबलीनंतर आता पुन्हा एकदा नवे रेकॉर्ड नोंदविले जाणार असल्याचे वृत्त आहे. प्रभासची प्रमुख भूमिका असलेला 'आदिपुरुष' बाहुबलीची सर्व रेकॉर्ड तोडेल असे सांगितले जात आहे. ११ ऑगस्ट २०२२ रोजी हा चित्रपट जगभरात एकाच वेळी २० हजार स्क्रीनवर रिलीज होणार असून एकाच वेळी इतक्या मोठ्या संख्येने रिलीज होणारा हा पहिलाच चित्रपट असेल. विशेष म्हणजे प्रमुख भारतीय भाषा शिवाय इंग्रजी भाषेत हा चित्रपट आहेच पण इंडोनेशिया, श्रीलंका, जपान, चीन मध्येही तेथील प्रादेशिक भाषांत हा चित्रपट रिलीज करण्याची तयारी केली गेली आहे.

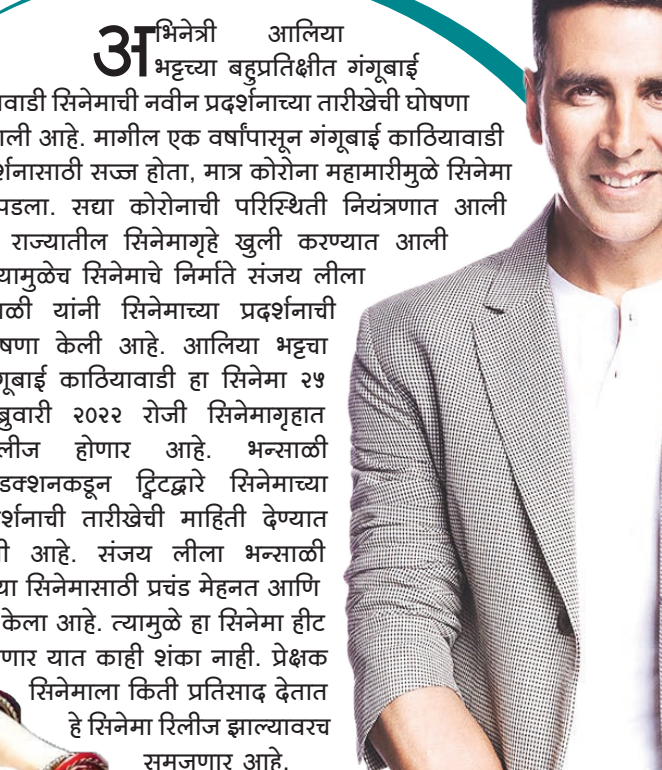

अभिनेत्री आलिया भट्टच्या बहुप्रतिक्षित गंगूबाई काठियावाडी सिनेमाची नवीन प्रदर्शनाच्या तारीखेची घोषणा करण्यात आली आहे. मागील एक वर्षापासून गंगूबाई काठियावाडी हा सिनेमा प्रदर्शनासाठी सज्ज होता, मात्र कोरोना महामारीमुळे सिनेमा फार लांबणीवर पडला. सद्या कोरोनाची परिस्थिती नियंत्रणात आली असून अनेक राज्यातील सिनेमागृहे खुली करण्यात आली आहेत. त्यामुळेच सिनेमाचे निमते संजय लीला भन्साळी यांनी सिनेमाच्या प्रदर्शनाची घोषणा केली आहे. आलिया भट्टचा गंगूबाई काठियावाडी हा सिनेमा २५ फेब्रुवारी २०२२ रोजी सिनेमागृहात रिलीज होणार आहे. भन्साळी प्रोडक्शनकडून टिट्टरारे सिनेमाच्या प्रदर्शनाची तारीखेची माहिती देण्यात आली आहे. संजय लीला भन्साळी यांनी या सिनेमासाठी प्रचंड मेहनत आणि पैसा खर्च केला आहे. त्यामुळे हा सिनेमा हीट होणार यात काही शंका नाही. प्रेक्षक सिनेमाला किती प्रतिसाद देतात हे सिनेमा रिलीज झाल्यावरच समजणार आहे.

बॉलिवूडचा खिलाडी अभिनेता अक्षय कुमार नेहमीच त्याच्या हटले अंदाजामुळे चर्चेत असतो. मात्र आता तो एका चित्रपटामुळे चर्चेत आहे. अक्षयच्या चित्रपटांची चर्चा ही रिलीज होण्यापूर्वीच सुरु असते. अक्षय सध्या अनेक चित्रपटांच्या शूटिंगमध्ये बिझी आहे. मात्र यातील एका तमीळ ब्लॉकबस्टर सूर्याई पोत्रू च्या हिंदी रिमेकमुळे अक्षय कुमारचे नाव चर्चेत आले आहे. बऱ्याच दिवसांपासून या चित्रपटाची चर्चा सुरु आहे. या चित्रपटासाठी अजय देवगण, हृतिक रोशन, जॉन अब्राहम आणि अक्षय कुमार यांसारख्या बॉलिवूडमधील टॉपच्या अभिनेत्यांची नावे चर्चेत होती. मात्र हा चित्रपट अक्षय कुमारच्या पदरी पडल्याचे बोलले जात आहे. या चित्रपटात अक्षय कुमार मुख्य भूमिकेत दिसणार आहे. मूळ तमिळ चित्रपटाचे दिग्दर्शन सुधा कोंगारा प्रसाद या बॉलिवूड रिमेकचे दिग्दर्शन करणार आहेत. हातातील एका चित्रपटाचे शूटिंग पूर्ण झाल्यावर अक्षय या चित्रपटाचे शूटिंग सुरु करणार असल्याचे म्हटले जातेय. सुर्याई दिग्दर्शित सूर्याई पोत्रू हा मुख्य चित्रपट एअर डेकनचे संस्थापक जीआर गोपीनाथ यांच्या जीवनावर आधारित आहे. एक वैमानिक ज्याने सामान्य माणसासाठी हवाई प्रवास परवडणारा व्हावा यासाठी एक योजना बनवण्याचे स्वप्न पाहिले. या प्रेरणादायी बायोपिकने देशातील अनेक उद्योजकांच्या जीवनावर प्रकाश टाकला आहे. दरम्यान हा तमीळ चित्रपट २०२० मध्ये OIT प्र प्रदर्शित झाला. आणि त्याला प्रेक्षकांचाही तुफान प्रतिसाद मिळाला.

भारतीय युवा संघाला वर्ल्डकप फायनलसाठी विराट कोहलीचा मोलाचा सल्ला



नवी दिल्ली : भारताच्या युवा संघाने वेस्ट इंडिज येथे सुरु असलेल्या आयसीसी २०२२ च्या विश्वचषकात ऑस्ट्रेलियाचा १६ धावांनी पराभव करत अंतिम फेरीत प्रवेश

केला. विश्वचषकाची अंतिम फेरी आज (५ फेब्रुवारी) होणार असून सर विवियन रिचर्ड्स स्टेडियमवर भारत वि. इंग्लंड संघ आमने-सामने येणार आहेत. इंग्लंडच्या युवा संघाने २४ वर्षांनंतर प्रथमच फायनलमध्ये प्रवेश केला आहे. अंतिम सामन्यात इंग्लंडचा कसा पराभव करायचा आणि विक्रमी पाचवे विजेतेपद कसे मिळवायचे याबद्दल भारताचा माजी कर्णधार विराट कोहलीने टीम इंडियाला मार्गदर्शन केले आहे. विराटने भारताच्या या युवा खेळाडूंना मार्गदर्शन केल्याचे भारताच्या युवा संघातील खेळाडू कौशल तांबेच्या इस्टाग्राम स्टेटसवरून

लक्षात आले. या स्टेटसमध्ये विराटने १९ वर्षांखालील संघाला विराटने व्हिडिओ कॉलकरून काही महत्त्वाच्या टिप्स दिल्या आहेत. कौशलच्या स्टेटसमध्ये विराटने सर्व खेळाडूंना व्हिडिओ कॉल केल्याचे दिसते. संघातील ऑलराउंडर राजवर्धन हॅगरगेकरने स्क्रीनशॉट शेअर करून लिहले आहे की, विराट कोहली भय्या तुमच्याशी चर्चा केल्यानंतर फार छान वाटले. क्रिकेट आणि आयुष्याबद्दल तुमच्याकडून फार महत्त्वाच्या गोष्टी जाणून घेता आल्या. येणाऱ्या काळात आम्हाला याचा फायदा होईल.

विराटने देखील ज्युनिअर स्तरावर भारतीय संघाचे नेतृत्व केले होते. त्याने २००८ साली झालेल्या कुआलालम्पुर येथे झालेल्या स्पर्धेत दक्षिण आफ्रिकेचा पराभव केला होता. तेव्हापासून १४ वर्षांत विराट भारतीय संघाचा कर्णधार होत आता अनुभवी कर्णधार आणि खेळाडू झालाय. विराटने १९ वर्षांखालील संघातील खेळाडूंशी बोलण्याची विनंती बीसीसीआय सचिव जय शहा किंवा राष्ट्रीय क्रिकेट अकादमीचे प्रमुख व्हीव्हीएस लक्ष्मण यांनी केली होती का हे अद्याप समजू शकले नाही. मात्र विराटने टीम इंडियातील खेळाडूंशी बोलून त्यांना प्रेरणा दिली आहे.

रोड सेफ्टी वर्ल्ड सिरीजसाठी पुन्हा एकदा निवृत्त क्रिकेटर्स उतरणार मैदानात

मुंबई : नुकत्याच पार पडलेल्या लिजेन्स क्रिकेट लीगनंतर आता पुन्हा एकदा आपल्याला निवृत्त क्रिकेटर्स मैदानात खेळताना दिसणार आहेत. रोड सेफ्टी वर्ल्ड सीरीजचे दुसरे पर्व फेब्रुवारीच्या शेवटच्या आठवड्यात सुरु होण्याची शक्यता आहे. या सीरीजचे सामने हैद्राबाद, विशाखापट्टणम, लखनऊ आणि इंदोर या ४ शहरांत खेळवले जाणार आहेत. दरम्यान उत्तर प्रदेशमध्ये निवडणुका असल्यामुळे लखनऊमध्ये होणारे सामने १० मार्चनंतर खेळवले जाण्याची शक्यता आहे. तर बाकी ३ शहरांमध्ये फेब्रुवारीच्या शेवटच्या आठवड्यापासूनच सामने खेळवले जाण्याची शक्यता आहे. दुबई येथे नुकत्याच पार पडलेल्या लिजेन्स क्रिकेट लीग पार पडली. या लीगमध्ये वर्ल्ड जायंट्स संघाने इंडियन महाराजा संघाचा पराभव केला. या लीगमध्ये क्रिकेटमधून निवृत्त झालेले दिग्गज खेळाडू

पुन्हा एकदा खेळताना आपल्याला दिसले होते. आता पुन्हा एकदा भारतात होणाऱ्या रोड सेफ्टी वर्ल्ड सीरीजच्या दुसऱ्या पर्वात आपल्याला दिग्गज क्रिकेटपटू खेळताना दिसून येणार आहेत. भारताचा मास्टर ब्लास्टर फलंदाज सचिन तेंडुलकरने लिजेन्स लीग खेळणार नसल्याचे आधीच सांगितले होते. पण तो आता रोड सेफ्टी वर्ल्ड सीरीजमध्ये मैदानात उतरण्याची शक्यता आहे. त्याच्यासोबतच विरेंद्र सेहवाग आणि युवराज सिंग व इतर अनेक दिग्गज खेळाडू खेळताना दिसणार आहेत. या सीरीजचे पहिले पर्व सचिनच्या संघाने जिंकले होते. अशी माहिती समोर आली आहे की,

रोड सेफ्टी वर्ल्ड सीरीज फेब्रुवारीच्या शेवटच्या आठवड्यात होणार असण्याची शक्यता आहे. या स्पर्धेचे आयोजक म्हणाले की, सध्या ही स्पर्धा आम्ही फेब्रुवारी ते मार्च दरम्यान सुरु करण्याचा विचार करत आहोत. आम्हाला फेब्रुवारीच्या शेवटच्या आठवड्यात स्पर्धा सुरु करायची आहे आणि अंतिम फेरी मार्चच्या शेवटच्या आठवड्यात संपेल. रोड सेफ्टी वर्ल्ड सीरीजच्या पहिल्या पर्वात भारत, इंग्लंड, दक्षिण आफ्रिका, श्रीलंका आणि वेस्ट इंडीज या संघांनी सहभाग घेतला होता. इंडिया लिजेन्स या संघाचा कर्णधार सचिन तेंडुलकर होता आणि हा संघ विजयी झाला होता.

# Indian sports pedals towards Olympic disciples that offer a bulk of medals

**New Delhi.** Next week, a seven-member Indian cycling team will travel to Antalya, Turkey, for a 53-day, first-ever, training-cum-competition stint. A tour of this nature, routine for most sports, would usually go unnoticed but this outing for the country's mountain bikers marks a significant policy change for Indian sports that is now targeting disciplines that offer a bulk of medals. "It is a sort of an investment," Pushpendra Garg, the CEO of the government's Target Olympic Podium Scheme (TOPS) told The Indian Express, adding that approximately Rs 40 lakh will be spent for the 53-day tour. "If they perform to a certain level, then we can go the whole hog." Cycling is one of the six sports which account for almost fifty percent of the medals at the Olympics, according to data crunching by Impact Analysis. In Tokyo last year, cycling had the third-highest number of gold medals on offer (22) after athletics and swimming. The high number of medals on offer means some countries have focused disproportionately on the sport to fuel their rise in the medals table, most notably by Britain which rode on the cycling wave for their rich medal hauls in the last three

Olympics. No Indian cyclist, however, has even come close to qualifying for the Games, let alone challenge for a medal. The last time an Indian cyclist competed at the Olympics was in 1964, and the only time the country finished on a podium in the sport at a multi-discipline event was at the 1951 Asian Games. The government, which funds a major portion of India's Olympic preparation, has finally begun to focus on one of the marquee sports at the Games. "Cycling is one of our priority disciplines," Garg said. "For last five years, since the starting of the cycling academy at the Indira Gandhi velodrome, we have been focusing on cycling a lot. In three years of good training, we were able to produce world junior number 1."

Garg is referring to Esow Alben, the prodigious talent from Andaman who topped the junior rankings chart in 2019 and also led the Indian team to a team gold medal at the junior track World Championship in the same year. Esow and his teammates, Laitonjam Ronaldo Singh and Rojit Singh Yanglem, have transitioned smoothly to the senior level,



with the Indian team ranked world number 20 while Ronaldo and Esow ranked inside the top-100 despite having last competed six months ago. The junior team's exploits became a catalyst for the growth, with centres of excellence and academies now being set up in different regions. Garg and cycling federation chief Onkar Singh are confident that the track cycling team will make the cut for the 2024 Paris Olympics, the qualification for which will begin in September this year. The track cyclists will hit the ground running from mid-February, set up a base in either Belgium or Slovenia and compete in tournaments in March and April. "In 2024, we don't want them to just

participate. Our KRA for them is finals qualification in the team event and individual, at least the second or third round," Garg said. While those may seem ambitious, lofty targets, the expectations from the mountain bikers are modest as they take the first step into a dizzying world of where every millisecond matters. Mountain biking has been at the Olympics since the 1996 Atlanta Games. But an Indian team did not exist until six years ago. It was only in 2016, that the country started competing continentally in the cycling event, when two cyclists took part in the Asian Championships. Even then, there were no coaches, no technicians and barely any certified competitions where they could take part – the first mountain biking race that got featured in the International Cycling Union (UCI) calendar took place only in 2019, the year when the team also had its first-ever national camp. "Even the equipment we used was very basic; sometimes, not even that. Like when I started, many of us did not even use cleats, which is a basic requirement in the sport," says Pranita Soman, one of the seven Turkey-bound cyclists.

## Pakistan pacer Mohammad Hasnain suspended from bowling due to illegal action

**New Delhi.** Pakistani pacer Mohammad Hasnain has been suspended from bowling after being found to have an illegal bowling action, the Pakistan Cricket Board (PCB) said on Friday. Hasnain's bowling action was reported by umpires in the recently concluded Big Bash League in Australia. "Keeping his future and Pakistan's interest at the forefront, the PCB... has decided he will not be allowed to continue to participate in the Pakistan Super League," it said. "Until Mohammad Hasnain clears his reassessment, he will remain suspended from bowling in international cricket." The PCB described the bowler as an "asset" citing his ability to bowl consistently at 145 kmph and was optimistic of his return to the game after remodelling his action.

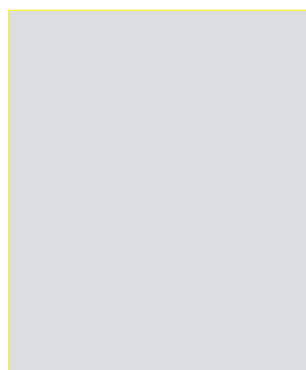
"The PCB has discussed the report with its own bowling experts and is confident that the problem can be resolved." He will use this time to work with the PCB-appointed bowling consultant to modify his bowling action so that he can apply for a reassessment and become eligible to return to international cricket. The 21-year-old Hasnain underwent the test at the ICC-accredited biomechanics laboratory in Lahore after finishing a productive five-game stint with Sydney Thunder. Hasnain, who once bowled a 155kmph delivery in the Caribbean Premier League (CPL), has played eight ODIs and 18 T20 Internationals after making his Pakistan debut in 2019. Coming in as a replacement for English pacer Saqib Mahmood, he made a strong impact in his debut season at the BBL, taking seven wickets from five matches at an average of 15.71 and an economy of 6.00 per over. Hasnain was due to undergo a test on his bowling action on January 19 in Australia, but because he was due to return to Pakistan at the end of his stint, it was decided he would get tested at the ICC-accredited testing facility in Lahore.

## Winter Olympics: Six German athletes test positive for Covid-19 on arrival in Beijing

**Beijing.** Germany's Winter Olympics team said that it had been hit by an outbreak of Covid-19 on arrival in Beijing, with six confirmed cases.

"Three teams of Team D (Germany) are affected," the German team said in a statement on Friday, without naming the people or sports teams affected. Those affected are all symptom-free and have been isolated from the rest of the team. "The team members are without symptoms and have been initially separated from the rest of the squad. There will be further PCR tests to confirm the results. The process from here on will be decided by the results." The other 78 athletes who arrived on the same flight had tested negative.

German figure skater Nolan Seeger has already tested positive for Covid-19 twice in Beijing and is isolated in a hotel, forcing Germany to drop out of the figure skating pairs in the team event. Organisers have said so far 287 Games participants, which includes athletes, coaches, officials, media and organising staff, had tested positive in Beijing. A total of 610,000 tests had been conducted until Thursday. Athletes who want to return to competition and training will need to be without symptoms and provide two negative tests 24 hours apart to be released from isolation.
