पाकिस्तानमध्ये बॉम्बस्फोट, ३० ठार

दहशतवादी गटांकडून निवडणुकांच्या पार्श्वभूमीवर राजकीय कार्यालये लक्ष्य क्वेटा, पाकिस्तान (एपी)

पश्चिम जिल्ह्यातील अपक्ष उमेदवार अस्फंदयार खान यांच्या निवडणूक कार्यालयावर झालेल्या पहिल्या हल्ल्यात किमान १७ जण ठार झाले. २० हून अधिक लोक जखमी झाले असून काहींची प्रकृती चिंताजनक असल्याचे पोलिसांनी सांगितले. थोड्याच वेळात, अखाकझाई आणि स्थानिक किला सैफुल्ला येथील प्रमुख कट्टरपंथी इस्लामिक पक्षाच्या कार्यालयात आणखी एका बॉम्ब स्फोटात १२ लोक मारले गेले तर किमान आठ जण जखमी झाले.

बलुचिस्तानमधील पंजगुर येथील वरिष्ठ पोलीस अधिकाऱ्यांनी सांगितले की, उमेदवार अस्फंदयार खान काकर यांच्या निवडणूक कार्यालयाबाहेर 'टायमर' लावलेल्या बंगेत बॉम्ब ठेवण्यात आला होता. काही जखमींची प्रकृती चिंताजनक असून त्यांना क्वेटा येथे उपचारासाठी नेण्यात आले आहे. स्फोटातील मृतांची संख्या वाढू शकते. लोकाना मतदान केंद्रांवर जाण्यापासून रोखण्यासाठी दहशतवादी उमेदवारांना लक्ष्य करत आहेत, मात्र निवडणुका वेळेवर व्हाव्यात यासाठी सुरक्षा कर्मचाऱ्यांची संख्या वाढवली जात आहे, असे त्यांनी सांगितले.

स्थानिक माध्यमांनी दिलेल्या वृत्तानुसार, किला अब्दुल्ला भागातील जेयूआय उमेदवारांच्या निवडणूक कार्यालयाचे मोठे नुकसान झाले. पाकिस्तानच्या निवडणूक आयोगाने दोन स्फोटांबाबत दुजोरा दिला आहे. तसेच देशभरात हजारो पोलीस आणि निमलष्करी दल तैनात करण्यात आले असल्याचे सांगितले.

काळजीवाहू पंतप्रधान अन्वारुल-हक-ककर यांनी बॉम्बस्फोटांचा निषेध केला. 'कायदा व सुव्यवस्था बिघडवण्याचा प्रत्येक प्रयत्न हाणून पाडला जाईल,' असे त्यांनी सांगितले. तसेच गुरुवारी शांततापूर्ण निवडणुका घेण्यास सरकार वचनबद्ध असल्याचेही ते म्हणाले.

पंतप्रधान मोदी यांचा आरोप

नवी दिल्ली : काँग्रेस देशाला उत्तर-दक्षिण असा तोडण्याचा प्रयत्न करत आहे. कितिदा जात-पात, भाषेच्या नावाखाली देशाचे विभाजन करणार आहात? काँग्रेसच्या विभाजनवादी विचारांमुळेच दहशतवाद, नक्षलवाद फोपावला होता. त्यामुळेच काँग्रेसने सैन्यदलाचे आधुनिकीकरण होऊ दिले नाही, असा आरोप पंतप्रधान नरेंद्र मोदी यांनी बुधवारी केला.

मोदींची टोलेबाजी

मल्लिकार्जुन खरगे यांची फिरकी घेतली. त्यांच्या 'चारसो पारड'च्या विधानाचा उल्लेख करत खरगेंनीच 'एनडीए'साठी ४०० जागांचा आशीर्वाद दिला आहे तर तो स्वीकारला पाहिजे.

राहुल गांधीचे निकटवर्तीय खरगेंना काम करू देत नसल्याची कोपरखळी मोदींनी मारली. सभागृहात राहुल गांधीचे दोन कमांडर नाहीत बघून खरगेंनी भाषणामध्ये चौकार-षटकार लगावले. मिळालेल्या 'स्वातंत्र्या'चा भरपूर फायदा खरगेंनी घेतला. ऐसा मौका फीर कर्हा मिलेगा... हे गाणे त्यांना आवडत असेल.

तृणमूल काँग्रेसच्या प्रमुख ममता बॅनर्जींनी आगामी लोकसभेत काँग्रेसला ४० जागाही मिळणार नसल्याचा दावा केला आहे. पण, मी प्रार्थना करतो की तुम्हाला ४० जागा तरी मिळोत.

अडथळे आणले. काँग्रेसचे माझ्याविरोधातील हल्ले मी सहन केले आहेत. पण, राज्यांच्या विकासातून राष्ट्राचा विकास झाला पाहिजे असे माझे मत आहे. त्यामुळे राज्यांच्या विकासाला मी महत्त्व देतो. आता तर स्पर्धात्मक संघ-राज्य असले पाहिजे. राज्या-राज्यांनी स्पर्धा करून विकास केला पाहिजे. पण, काँग्रेस वेगळ्या राष्ट्राची भाषा करत आहे. अखेच राज्य सरकार त्यासाठी आंदोलन करत आहे. ही बाब दुर्दैवी आहे.'

करोनाच्या काळात राज्यांच्या मुख्यमंत्र्यांच्या २० वेळा बैठका घेतल्या. राज्यांचे सहकार्य घेऊन मुर्मु यांच्याकडे पाठविले जाईल. त्यांनी शिक्काकर्तव्य केल्यानंतर उत्तराखंडमध्ये समान नागरी कायदा लागू होईल.

3) All the bids/ tenders submitted for the purchase of the above property/s shall be accompanied by Earnest Money as mentioned above. EMD amount favouring the "India Shelter Finance Corporation Limited" payable at Delhi. The EMD amount will be returned to the unsuccessful bidders after auction.
