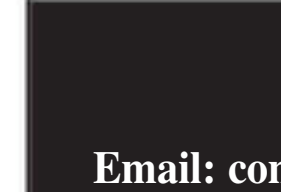

संधाबाहेरचा रस्ता दाखवण्यात आला. विशेष म्हणजे, त्या मालिकेत भारतीय संघातील अन्यही फलंदाज अपयशी ठरले होते. तरीही केवळ सर्फराजलाच संघातील स्थान गमवावे लागले. त्यानंतर इंग्लंड दौऱ्यातील ‘अ’ संघाच्या सामन्यात सर्फराजने ९२ धावांची खेळी केली. तसेच भारत विरुद्ध भारत ‘अ’ अशा सराव सामन्यात त्याने शतकही झळकावले. तरीही तो राष्ट्रीय संघापासून दूरच राहिला. भारताचा दक्षिण आफ्रिकेविरुद्ध घरच्या मैदानावर झालेला निराशाजनक पराभव आणि त्यानंतर निर्माण झालेल्या परिस्थितीने मात्र बदलाचे संकेत दिले. आता श्रीलंकेतील फिरकीला अनुकूल खेळपट्ट्या लक्षात घेऊन सर्फराजला संधी देणे निवड समितीला भाग पडले आहे.

पात्रतेचे स्वप्न भंगले आहे. दक्षिण आफ्रिका, नामिबिया आणि झिम्बाब्वे येथे संयुक्तपणे होणाऱ्या २०२७च्या विश्वचषकासाठी यजमान देश वगळता ‘आयसीसी’ क्रमवारीतील अव्वल आठ पूर्ण सदस्य संघांना थेट प्रवेश मिळणार आहे. दक्षिण आफ्रिका हा अव्वल आठमध्ये असलेला यजमान संघ आहे. त्यामुळे क्रमवारीतील नवव्या स्थानावरील संघालाही थेट पात्रतेची संधी मिळणार आहे. सध्या बांगलादेश नवव्या, वेस्ट

इंडिज दहाव्या आणि झिम्बाब्वे ११व्या क्रमांकावर आहे. वेस्ट इंडिजला नवव्या स्थानावर पोहोचण्यासाठी आयर्लंडने अफगाणिस्तानविरुद्धची मालिका ५-० किंवा ४-१ अशी जिंकणे आवश्यक होते. मग भारताविरुद्धच्या आगामी एकदिवसीय मालिकेत विंडीजला २-० असा विजय मिळवावा लागणार होता. मात्र, आयर्लंड-अफगाणिस्तान मालिकेतील निकालामुळे विंडीजला आवश्यक समीकरण पूर्ण होणे शक्य नाही.
