1. Background

Pursuant to the above-mentioned provisions, we hereby intimate the Stock Exchanges of certain material developments pertaining to the Company's physical infrastructure, operational capacity, human resources, and senior leadership. These developments have been approved by the Board of Directors and are being disclosed in the interest of transparency and investor awareness.

2. Relocation and Consolidation of Office Premises

The Company was previously operating out of two offices – an approximately 3,500 sq. ft. premises at Gurugram and an approximately 2,500 sq. ft. premises at Faridabad, aggregating to approximately 6,000 sq. ft. of occupied space.

The Company has now consolidated its operations into a new, larger facility located at Sector 27, Gurugram, Haryana. The new premises admeasure approximately 15,000 sq. ft., representing an expansion of approximately 2.5 times the Company's previous aggregate footprint. This consolidation is intended to improve operational efficiency, facilitate cross-functional collaboration, and support the Company's near-term growth objectives.

3. Commissioning of Robotesting Laboratory and Assembly Unit

Within the new facility, the Company has commissioned the following dedicated operational units, which form an integral part of its product and technology infrastructure:

- Robo-testing Laboratory: A dedicated quality assurance and automated testing laboratory to support the Company's software and hardware product lines.
- Biometric Device and Identity Technology (IDT) Assembly Unit: An in-house assembly unit for the manufacturing and integration of biometric devices and IDT products, enabling greater control over product quality, delivery timelines, and cost efficiency.

These facilities are expected to materially strengthen the Company's product development and delivery capabilities.

4. Expansion of Workforce

The Company has recently onboarded 22 new employees across technology, operations, and product functions. The total employee strength of the Company presently stands at 123. As the Company scales its operations, the headcount is expected to reach approximately 200 employees in the near term.

5. Appointment of Chief Technology Officer
