These standalone financial results have been prepared in accordance with the Companies (Indian Accounting Standards) Rules, 2015 (as amended) (Ind AS) prescribed under Section 133 of the Companies Act, 2013 and other recognized accounting practices and policies to the extent applicable. The Statutory Auditors of the Company have conducted an audit of these standalone financial results of the Company for the quarter and year ended March 31, 2026, in accordance with Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and expressed an unmodified audit opinion on these results.

2 The figures for the quarter ended March 31, 2026 are the balancing figures between audited figures in respect of full financial year ended March 31, 2026 and the unaudited published year to date figures upto December 31, 2025, being the end of the third quarter of the financial year which were subjected to limited review. The previous period figures have been regrouped, wherever considered necessary.

3 During the year, the Company allotted 26,92,409 equity shares of ₹ 10/- each at a premium of ₹ 66/- per share (issue price ₹ 76/-) to the shareholders of Carya Chemicals & Fertilizers Private Limited ("CCFPL"), as consideration other than cash, pursuant to a share swap arrangement for acquisition of 1,62,39,946 equity shares of CCFPL. The swap price was determined based on a registered valuer's report dated March 29, 2025, in compliance with SEBI (ICDR) Regulations, 2018.

4 During the year, the company had issued 2,99,25,394 partly paid-up equity shares of face value of Rs.10/- each on right basis. An amount of Rs.2,50/- per equity share was received on application and the shares were allotted accordingly. As at March 31,2026, first call money had been received in respect of 2,97,58,765 partly paid-up equity shares (Rs.5/- paid up) and first call money aggregating to Rs. 4,21,572.50 remained outstanding. The balance 50% of the issue price has not yet been called up by the Board of Directors.

5 The company has two business segments- a) Liquor operations (b) Trading Operations. The Segment reporting is being accordingly made. However, during the quarter and year ended 31st March 2026 there have been no operations in the Trading Segment.

6 Previous period's figures have been regrouped/ re-arranged, wherever necessary.

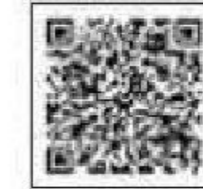
