As on date, the paid- up equity share capital of MECPL is held by the Company and Biel Crystal (Singapore) Private Limited, in the ratio of 90% (Ninety percent) and 10% (Ten percent), respectively.

Further, the issuance of the afore-mentioned corporate guarantee is pursuant to and in accordance with the shareholders’ approval of the Company at 39th Annual General Meeting held on July 30, 2026. The Company’s potential liability under the afore-mentioned corporate guarantee is capped upto the facility amount i.e. upto INR 16,000,000,000/- (Indian Rupees Sixteen Thousand Million only) and interest thereon.
