Sanjay Jadhav was recruited as a garden superintendent on a technical post. Municipal Commissioner Dr. BhausahebDangde) had removed him from this post and appointed Deputy Commissioner DhairyasheelJadhav in his place. He had been serving as the in-charge secretary of the Municipal Corporation for resourcement in the contraction for resourcement in the contractio Municipal Corporation for many years in the Municipal Building, Many had filed complaints with the Commissioner to remove him from the post.As per the order referred to, Sanjay Jadhav, Chief Park Superintendent, has been given the additional charge of the post of "Municipal Secretary". For the convenience of administrative work, the additional charge of the post of "Municipal Secretary" held by Sanjay Jadhav is being terminated, and the said charge is being given to DhairyasheelJadhav, Deputy Commissioner Zone-1 until further orders Commissioner Zone-1. until further orders. Jadhav had been removed from the post of "Municipal Secretary" along with his charge, but new Commissioners kept coming to KDMC and Sanjay Jadhav was being neglected and his post was being neglected. Meanwhile, Sanjay Jadhav has been illegally holding the post of Secretary for six years. There is talk that Sanjay Jadhav has reached a high postlion due to political favors. Sanjay Jadhav was dreaming of hexporting Additional Commissioner from the becoming Additional Commissioner from the post of Deputy Commissioner, but this dream post of Deputy Commissioner, but this dream has been shattered and Jadhav's run has started. The issue of Sanjay Jadhav being raised by MLA Anil Parab in the winter session is raising questions on the administration of KalyanDombivali Municipal Corporation. It is being said among the citizens that it is necessary to investigate who exactly was involved in this illegal act. The demand for an investigation into the assets of many administrative officials is gaining momentum.
