We refer to our earlier intimation dated 30 January 2026, wherein we had informed that MPS North America LLC (“MPS NALLC”), a wholly-owned subsidiary of MPS Limited (“the Company”), had entered into a Stock Purchase Agreement (“SPA”) dated 30 January 2026 for the acquisition of 100% stake in Unbound Medicine, Inc., USA, for a total consideration of USD 16.50 million (subject to customary adjustments), payable in accordance with the terms and conditions set out in the SPA and other definitive transaction documents.

We hereby inform you that, pursuant to the terms of the SPA and upon satisfaction of the customary closing conditions, the transaction has been successfully completed, and MPS NALLC has paid the consideration due at completion and acquired 100% stake in Unbound Medicine, Inc., USA. Accordingly, Unbound Medicine, Inc., USA has become a wholly-owned step-down subsidiary of MPS Limited with effect from the date of completion.

The details of the acquisition as required to be disclosed under Regulation 30 read with Para A of Part A of Schedule III of the SEBI Listing Regulations and SEBI Master Circular No. HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated 30 January 2026, have already been disclosed vide our letter dated 30 January 2026.
