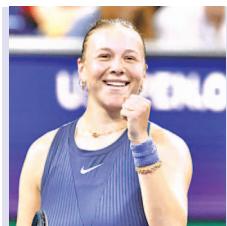

टेनिस टूर्नामेंट: लोरेंजो मुसेट्टी और इगा स्वियातेक हारकर बाहर सिनर और अनिसिमोवा ने अमेरिकी ओपन के सेमीफाइनल में किया प्रवेश

न्यूयॉर्क,एजेंसी। वर्ल्ड नंबर 1 जैनिन सिनर ने अमेरिकी ओपन 2025 में धमाकेदार मुकाबले में शानदार जीत दर्ज कर पुरुष एकल वर्ग के सेमीफाइनल में प्रवेश कर लिया है। उन्होंने क्वार्टर फाइनल में शानदार खेल दिखाया और अपने हमवतन लोरेंजो मुसेट्टी को हराकर अंमि-4 में जगह पक्की की। वहीं, महिला एकल में आठवीं वरीयता प्राप्त अमेरिकी खिलाड़ी अमांडा अनिसिमोवा ने इगा स्वियाटेक को हराकर यूएस ओपन के सेमीफाइनल में प्रवेश किया।

जैनिन सिनर ने लोरेंजो मुसेट्टी पर सीधे सेटों में जीत दर्ज कर ली। इस पूरे मैच के दौरान सिनर खतरनाक लगे जबकि मुसेट्टी काफी फोके नजर आए। उन्होंने दो घंटे में 6-1, 6-4, 6-2 से जीत हासिल कर ली। जैनिन सिनर ओपन एरा में एक ही सीजन में चारों ग्रैंड स्लैम के सेमीफाइनल में पहुंचने वाले पहले इतालवी खिलाड़ी बन गए हैं। उनसे पहले कोई भी अन्य इतालवी टेनिस प्लेयर एक सीजन के सभी 4 ग्रैंड स्लैम के सेमीफाइनल या फाइनल में जगह नहीं बना पाए हैं।



भांबरी का सर्वश्रेष्ठ प्रदर्शन, युगल सेमीफाइनल में पहुंचे

भारत के युकी भांबरी अपने जोड़ीदार न्यूजीलैंड के माइकल वीनस के साथ पहली बार किसी ग्रैंडस्लैम पुरुष युगल के सेमीफाइनल में पहुंच गए। भांबरी और वीनस ने 11वीं वरीयता प्राप्त निकोला मेकटिच और राजीव राम को 6-3, 6-7, 6-3 से हराया। इससे पहले उन्होंने चौथी वरीयता प्राप्त जर्मनी के केविन क्रावीत्ज और टिम पुएल्ज को मात दी थी। तैतीस वर्ष के भांबरी चोटों से परेशान रहने के बाद एकल छोड़कर युगल पर फोकस कर रहे हैं। दुनिया के पूर्व जूनियर नंबर एक खिलाड़ी भांबरी का सीनियर ग्रैंडस्लैम में यह सर्वश्रेष्ठ प्रदर्शन है। इसके साथ ही पुरुष युगल में भारत का दबदबा लिंडर पेस, महेश भूपति और रोहन बोपन्ना के बाद भांबरी ने बरकरार रखा है। अब भांबरी और वीनस का सामना छठी वरीयता प्राप्त ब्रिटेन के जो सालिस्बरी और नील स्कूपरस्की से होगा।



अमांडा अनिसिमोवा ने इगा स्वियातेक से लिया बदला

महिला एकल में अमेरिका की आठवीं वरीयता प्राप्त टेनिस खिलाड़ी अमांडा अनिसिमोवा ने शानदार प्रदर्शन करते हुए पोलैंड की दूसरी वरीयता प्राप्त इगा स्वियातेक को 6-4, 6-3 से हराकर सेमीफाइनल में प्रवेश किया। इसके साथ ही अनिसिमोवा ने विंबलडन फाइनल में मिली हार का बदला भी ले लिया। जुलाई में विंबलडन फाइनल में स्वियातेक ने उन्हें 6-0, 6-0 से पराजित किया था। 24 वर्षीय अनिसिमोवा अब सेमीफाइनल में दो बार की यूएस ओपन चैंपियन नाओमी ओसाका या चेक गणराज्य की 11वीं वरीयता प्राप्त कैरोलिना मुचोवा से भिड़ेंगी।



अमेरिका में भारतीय छात्रों पर सख्ती, वीजा और जॉब पर दोहरी मार, 4700 के वीजा रद्द

नई दिल्ली,एजेंसी। भारत पर भारी-भरकम टैरिफ लगाने वाले अमेरिकी राष्ट्रपति डोनाल्ड ट्रंप के प्रशासन ने अब वहां रह रहे भारतीय छात्रों पर सख्ती बरतनी शुरू कर दी है। इससे वहां पढ़ाई कर रहे छात्रों को मुश्किलों का सामना करना पड़ रहा है। ट्रंप प्रशासन ने वीजा नियमों में सख्ती बरत दी है। इसकी वजह से वहां पार्ट टाइम काम कर रहे छात्रों की नौकरियों पर संकट आ गया है।

सख्त वीजा नियमों के चलते अमेरिकी नियोजता भारतीय छात्रों को पार्ट टाइम जॉब नहीं दे रहे हैं या दे भी रहे हैं तो काम के घंटे बहुत कम हैं, जिससे उनकी आमदनी कम हो गई है। आधिकारिक रिकॉर्ड बताते हैं कि हाल के महीनों में कॉलेजों में पर्याप्त उपस्थिति नहीं होने या अनधिकृत रोजगार के कारण 4,700 से ज्यादा छात्रों के वीजा रद्द कर दिए गए हैं। लॉस एंजिल्स में साइबर सुरक्षा में

मास्टर डिग्री कर रहे 25 वर्षीय छात्र ने अपनी परेशानी बताते हुए कहा, पहले, मैं पढ़ाई और एक रेस्टोरेंट में नौकरी के बीच संतुलन बना लेता था। मैं दिन में कम से कम आठ घंटे काम करता था लेकिन जांच शुरू होने के बाद, मेरे नियोजता ने सभी छात्र कर्मचारियों को नौकरी से निकाल दिया है।

इससे आर्थिक संकट गहरा गया है। एक अन्य छात्र ने बताया कि उसे एक रेस्टोरेंट में नौकरी तो मिल गई, लेकिन दिन में तीन घंटे से ज्यादा काम करने की इजाजत नहीं दी गई। इससे कमाई कम हो गई। अब ऐसे छात्र न तो किराये का प्रबंध कर पा रहे हैं और न ही किराने के सामान का। आर्थिक तंगी के कारण कई छात्रों को या तो बहुत छोटे से चयन में रहना पड़ रहा है या फिर एक ही रूम में कई छात्रों को रहने पर मजबूर होना पड़ा है।

जमैका के पीएम होलनेस ने तीसरी बार चुनाव में जीत हासिल की

किंस्टन,एजेंसी। भ्रष्टाचार, असमानता और आर्थिक समस्याओं से त्रस्त जमैका के प्रधानमंत्री एंड्रयू होलनेस ने बृहस्पतिवार तड़के एक कड़े मुकाबले के बाद तीसरी बार चुनाव में जीत हासिल की। प्रारंभिक परिणामों से पता चला है कि होलनेस की जमैका लेबर पार्टी ने कम से कम 34 सीट जीती हैं, जबकि मार्क गोल्लिडग की विपक्षी पीपुल्स नेशनल पार्टी ने कम से कम 29 सीट पर जीत हासिल की है। गोल्लिडग ने एक संक्षिप्त भाषण में चुनावी हार स्वीकार करते हुए कहा कि वह नतीजों से निराश हैं।

संयुक्त राष्ट्र,एजेंसी। अमेरिका और पनामा ने संयुक्त राष्ट्र सुरक्षा परिषद से अनुरोध किया है कि वह हैती में बढ़ती हिंसा को रोकने में मदद के लिए 5,550 सदस्यीय सुरक्षा बल को भेजने के प्रस्ताव को मंजूरी दे। मसौदा प्रस्ताव में कहा गया है कि इस सुरक्षा बल के पास गिरोह के सदस्यों को हिरासत में लेने की शक्ति होगी। दोनों देशों ने संयुक्त राष्ट्र सुरक्षा परिषद में एक मसौदा प्रस्ताव में कैरेबियाई राष्ट्र हैती में तैनात केन्या के नेतृत्व वाले बहुराष्ट्रीय सुरक्षा बल को एक बहुत बड़े सुरक्षा बल में बदलने के अपने विचार की रूपरेखा प्रस्तुत की।

नई दिल्ली, एजेंसी। टीम इंडिया को टी20 वर्ल्ड कप 2022 के सेमीफाइनल में इंग्लैंड के खिलाफ 10 विकेट से मिली हार के बाद दिग्गज भारतीय तेज गेंदबाज भुवनेश्वर कुमार का पता टीम से कट गया। अब 3 साल के बाद भी उनकी किसी भी फॉर्मेट में वापसी नहीं हो पाई है। इस पर भुवनेश्वर कुमार ने खुलकर बात की है। भुवनेश्वर ने अपनी वापसी पर कहा, इसका जवाब तो चयनकर्ता ही दे पाएंगे। मेरा काम है मैदान पर 100 प्रतिशत देना और मैं वो कर रहा हूँ। अगर मुझे यूपी लीग के बाद मुश्ताक अली, रणजी



फिटनेस और लाइन-लेथ पर रहता है। आप कितना भी अच्छा प्रदर्शन करें कभी-कभी किस्मत आपका साथ नहीं देती है। इसके अलावा रियटायरमेंट के सवाल पर भी भुवी ने साफ कह दिया कि फिलहाल उनका ऐसा कोई प्लान नहीं है। भुवनेश्वर ने भारत के लिए 121 वनडे, 21 टेस्ट और 87 टी20 मैच खेले हैं। उन्होंने 294 विकेट लिए हैं।

इरफान ने हुक्का विवाद पर तोड़ी चुप्पी पहले लगाए आरोप, अब दी सफाई

नई दिल्ली,एजेंसी। पूर्व भारतीय क्रिकेटर इरफान पठान का एक पुराना वीडियो सोशल मीडिया पर वायरल हो गया। इस वीडियो में वे एमएस धोनी पर निशाना साधते हुए नजर आए। लेकिन अब उन्होंने सफाई दी है। इस वीडियो में वो खिलाड़ियों के हुक्का भरने के बारे में बात कर रहे थे।

इस वीडियो में उन्होंने धोनी पर हुक्का पीने और उन लोगों का पक्ष लेने का आरोप लगाया था जो उनके साथ इन सत्रों में शामिल होते थे। यह वीडियो सोशल मीडिया पर वायरल हो गया और इसने फैस के बीच गरमागरम बहस को जन्म दे दिया।

पठान ने वीडियो के फिर से सामने आने पर भी अपनी बात रखी। उन्होंने इसके अचानक ऑनलाइन



लिखने के पीछे पीआर एजेंडा और फैस के बीच युद्ध को कारण बताया। पठान ने लिखा, आधे दशक पुराना वीडियो अब एक मुड़े हुए संदर्भ के साथ सामने आ रहा है। फैन वार? पीआर लॉबी? उस पुरानी बातचीत में, पठान ने उन्हें मिले सीमित अवसरों पर विचार किया।

उन्होंने 2008 की सीबी सीरीज को याद किया जब उन्होंने मीडिया रिपोर्टों पर धोनी से सवाल किया था। उन रिपोर्टों में कहा गया था कि कप्तान उनकी गेंदबाजी से खुश नहीं थे। यह क्लिप सुर्खियों में आई क्योंकि पठान ने यह भी संकेत दिया कि धोनी हुक्का पीते थे और उन खिलाड़ियों को पसंद करते थे जो उनके साथ शामिल होते थे।

प्रवर्तन निदेशालय ने अवैध सट्टेबाजी ऐप मामले में धवन को पूछताछ के लिये समन किया

नई दिल्ली,एजेंसी। प्रवर्तन निदेशालय (ईडी) ने भारत के पूर्व क्रिकेटर शिखर धवन को बृहस्पतिवार को एक कथित अवैध सट्टेबाजी ऐप से जुड़े धन शोधन मामले में पूछताछ के लिए समन किया है। आधिकारिक सूत्रों ने बताया कि जांच एजेंसी 'वन एक्स बेट' नामक एक अवैध सट्टेबाजी ऐप से जुड़ी इस जांच के तहत धन शोधन निवारण अधिनियम (पीएमएलए) के तहत उनका बयान दर्ज करेगी। ऐसा माना जा रहा है कि 39 वर्षीय पूर्व भारतीय क्रिकेटर कुछ विज्ञापनों के जरिए इस ऐप से जुड़े हैं। ईडी पूछताछ के दौरान इस ऐप से उनके संबंधों को समझना चाहता है। एजेंसी अवैध सट्टेबाजी ऐप्स से जुड़े ऐसे कई मामलों की जांच कर रही है जिन पर कई लोगों और निवेशकों से करोड़ों रुपये की ठगी करने या भारी कर चोरी का आरोप है।

Signature Global's shares down over 18.3 pc so far this year

Mumbai, Sep 3 (IANS) Gurugram-based real estate developer Signature Global has seen a significant drop in its share price so far this year as on a year-to-date (YTD) basis, the stock is down by 18.41 per cent, or Rs 249.15, according to official data.

Over a one-year period, the company's shares have declined by 21.63 per cent, amounting to a loss of Rs 305.05.

However, in recent months, the stock has shown some signs of stability. In the last six months, it has gained 5.36 per cent or Rs 56.2, though that short-term rise hasn't been enough to reverse the broader downward trend.

In the past one month, Signature Global's stock

fell again, delivering a negative return of 4.64 per cent or Rs 53.8.

Over the last five trading sessions, the stock was mostly flat, inching up by 0.03 per cent or just Rs 0.30.

On Wednesday, shares of the company were trading at Rs 1103.3, up Rs 15.8 or 1.45 per cent -- indicating mild intraday strength.

The stock's uneven performance comes on the back of a mixed financial report card. In early August, Signature Global reported a sharp 43.71 per cent drop in net profit for the first quarter (Q1) of FY26.

The company posted a profit of Rs 34.4 crore, down from Rs 61.1 crore in the previous quarter (Q4 FY25), despite a

66.33 per cent jump in operational revenue to Rs 865.6 crore.

The fall in profit was attributed to rising expenses and a 34.80 per cent decline in other income, which came in at Rs 32.6 crore.

Total expenses jumped to Rs 852.6 crore, up 71.30 per cent quarter-on-quarter, according to its stock exchange filing.

Nevertheless, Signature Global continues to pursue its growth strategy. During the quarter, it acquired 9.96 acres of land in Sohna, with a development potential of 0.53 million sq. ft., and successfully launched its premium residential project, Cloverdale SPR, in Sector 71, Gurugram.

Chairman and Whole-Time Director Pradeep Kumar Aggarwal said the company delivered a "robust performance" operationally in Q1 FY26, and remains focused on customer satisfaction and timely project delivery.
