We hereby appraise that pursuant to Regulation 15(2) of the Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended from time to time (hereinafter referred to as the said "SEBI (LODR) Regulations, 2015"), the compliance with the corporate governance provisions as specified in regulations 17, 17A, 18, 19, 20, 21, 22, 23, 24, 24A, 25, 26, 26A, 27 and clauses (b) to (i) and (t) of sub regulation (2) of regulation 46 and para C, D and E of Schedule V shall not apply (hereinafter referred to as the said "Corporate Governance - Exemption Provisions"), when Listed Company is attaining any of below stated criteria:

A. a Listed entity having

- i. paid up equity share capital not exceeding rupees ten crore and
- net worth not exceeding rupees twenty-five crore, as on the last day of the previous financial year i.e. 31st March, 2025;
- B. a Listed entity which has listed its specified securities on the SME Exchange.

Further proviso to Regulation 15(2)(a) states that incase this provision becomes applicable to the Listed Entity, the same shall be complied within Six months from such date.

Further pursuant to Regulation 27(2) of the said SEBI (LODR) Regulations, 2015, every listed entity is required to submit a quarterly compliance report on corporate governance in the format specified by the SEBI from time to time to recognized Stock Exchange(s).

Please note that:

 Madhya Pradesh Today Media Limited (hereinafter referred to as the "Company") has listed its Equity Shares on SME Platform of National Stock Exchange of India Ltd ("NSE EMERGE").
