We write to inform that the Company has received notices from BSE Limited (BSE) and National Stock Exchange of India Limited (NSE) for non-compliance of provisions of Regulation 17 (1) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 w.r.t composition of the Board for the quarter ended September 30, 2025 and consequent levy of fine from the Stock Exchanges as detailed below:
