Dear Sir,

In compliance of Regulation 30 of SEBI (LODR) Regulations, 2015 and in terms of Sub-Para 20 of Para A of Part A of Schedule III, this is to inform you that MTNL has received Letter No. NSE/LIST/C/2025/1268 dated 28.11.2025 from NSE and Email/Letter No. SOP-CReview/QTR-September 2025 dated 28.11.2025 from BSE regarding Non-Compliance with the provisions of Regulation 17(1) of SEBI (LODR) Regulations, 2015 respectively i.e. Non-compliance with the requirements pertaining to the Composition of the Board.

In this regard both NSE and BSE has imposed fines on MTNL amounting to Rs. 5,42,800/- (inclusive of Basic fines amounting to Rs. 4,60,000/- and GST @18% amounting to Rs. 82,800/-) respectively.

It is to be informed you that MTNL is a Public Sector Undertaking. All appointments including Independent Directors on the Board are made by the Administrative Ministry i.e. Department of Telecommunications (DoT), Ministry of Communications, Government of India. Two Independent Directors including one Women Independent Director were appointed by DoT vide Letter No. E-5-3/2018-PSA dated 15.04.2025 w.e.f. 15.04.2025. The matter for appointment of four more Independent Directors has already been taken up with the Government of India. The Company is also requesting to NSE and BSE for waiver of fines.

Details pursuant to Sub-Para 20 of Para A of Part A of Schedule III is attached herewith.
