Pursuant to Regulations 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”) read with Schedule III to the Listing Regulations, this is to inform you that the Board of Directors of the Company, at its Meeting held today, i.e., on Thursday, November 6, 2025 (which commenced at 04:30 p.m. and concluded at 5:15 p.m.), inter alia, has approved / noted the followings:-

1. The Company has on November 6, 2025 entered into the Definitive Agreements with the relevant parties for acquisition of Equity stake in Bimapay Finsure Private Limited and in connection with the proposed acquisition of stake in the aggregate paid-up share capital of Bimapay Finsure Private Limited.

The purchase consideration for the proposed acquisition shall be paid by the Company by way of equity share swap, i.e., issuance of its own fully paid-up equity shares to the relevant parties on a preferential basis. Further, the said proposed acquisition is subject to completion of customary conditions precedent and obtaining the relevant regulatory approvals as may be required under the applicable law(s) including without limitation the approval of the shareholders of the Company.
