Sir/ Madam,

Please find attached the disclosure under Regulation 29(1) of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulation, 2011, in connection with the following acquisition and settlement of equity shares of Muthoot Fincorp Limited (MFL):

Initial transfer to their spouse (Phase I):

- (i) Mrs. Preethi John Muthoot acquired by way of gift MFL equity shares amounting to 94,320,557 with a face value of Rs.2 each from Mr. Thomas John Muthoot, thereby increasing her shareholding to 15.99% (from 6.35%) and consequently, reducing Mr. Thomas John Muthoot's shareholding to 16.47% (from 26.12%).
- (ii) Mrs. Nina George acquired by way of gift MFL equity shares amounting to 94,320,562 with a face value of Rs.2 each from Mr. Thomas George Muthoot, thereby increasing her shareholding to 15.86% (from 6.22%) and consequently, reducing Mr. Thomas George Muthoot's shareholding to 16.35% (from 25.99%).
- (iii) Mrs. Remmy Thomas acquired by way of gift MFL equity shares amounting to 94,320,562 with a face value of Rs.2 each from Mr. Thomas Muthoot, thereby increasing her shareholding to 15.99% (from 6.35%) and consequently, reducing Mr. Thomas Muthoot's shareholding to 16.47% (from 26.12%).

Mrs. Preethi John Muthoot, Mrs. Nina George and Mrs. Remmy Thomas are collectively referred to as "Phase I Acquirers".

Settlement to Trust (Phase II):

After initial transfer of shares to their respective spouses, Mr. Thomas John Muthoot, Mr. Thomas George Muthoot, Mr. Thomas Muthoot and their respective spouses (collectively "Promoter and Promoter Group / Settlers") have settled the shares held by them aggregating to 65,28,72,800 equity shares representing 66.76% of MFL equity share capital, into their respective trusts namely Thomas John Muthoot (MF) Trust, Thomas George Muthoot (MF) Trust, Thomas Muthoot (MF) Trust, Preethi John Muthoot (MF) Trust, Nina George (MF) Trust and Remmy Thomas (MF) Trust (collectively referred to as "Phase II Acquirers").

The acquisition and settlement of MFL shares is pursuant to SEBI exemption order number WTM/KCV/CFD/10/2026-27 dated August 3, 2026. This disclosure is jointly made by Phase I and II Acquirers. Additionally, please note that there is no change in the total shareholding of the Promoter and Promoter group in Muthoot Microfin Limited (MML), the target company, after the aforesaid transactions.
