**Sub: Outcome of Board Meeting held on January 23, 2026 in pursuance to the Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('SEBI Listing Regulations')**

In Consonance to our prior intimation of Board Meeting dated January 19, 2026 and in line with the captioned subject, we would like to inform that the meeting of the Board of Directors of the Company held today i.e. **Friday, January 23, 2026**, has inter alia, considered and approved the followings items of agenda:

**1. Raising of Funds through Issuance of the equity shares by way of preferential issue on private placement basis ("Preferential Issue"):**

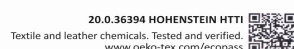
The Board has approved the issuance of up to **28,53,000 (Twenty-Eight Lakh Fifty-Three Thousand)** Equity shares of face value ₹10/- each, at an issue price of ₹ 166/- (Rupees One Hundred Sixty-Six Only) per equity share, including a premium of ₹156/- per share, aggregating to **₹ 47,35,98,000 (Rupees Forty-Seven Crore Thirty-Five Lakh Ninety-Eight Thousand Only)**, by way of preferential allotment on a private placement basis, to the proposed allottees ("**Preferential Issue**").

The issue price shall be in compliance with the provisions of Chapter V of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended ("SEBI ICDR Regulations"), and shall not be less than the floor price determined in accordance therewith.

The Preferential Issue is subject to:

- approval of the members of the Company, and
- receipt of such other statutory, regulatory, stock exchange and governmental approvals as may be required.
