This is further to our letter dated 24th June, 2025 wherein the Company had informed about entering into Share Subscription and Shareholders Agreement (SSSHA) by the CIE Aluminium Casting India Limited (CIEALCAST) (a wholly owned subsidiary company) with AMPIN Energy C&I Thirty One Private Limited ("AMPIN Energy Thirty One") to invest and subscribe upto 29% of the equity, on fully diluted basis, of AMPIN Energy Thirty One and invest an amount upto Rs. 1,75,00,000/- (Rupees One Crore Seventy Five Lacs only) towards subscription of its equity shares which shall constitute about 40% of the paid-up equity share capital carrying voting rights of AMPIN Energy Thirty One.

We wish to inform that, , AMPIN Energy Thirty One has today i.e. 2nd December, 2025 allotted 8,75,000 equity shares of Rs. 10/- each for an aggregate consideration of Rs. 87,50,000/- (Rupees Eighty Seven Lacs Fifty Thousand Only) to CIEALCAST which constitute 39.91% of the Paid-up Share Capital of AMPIN Energy Thirty One (First Tranche Investment). Thus, AMPIN Energy Thirty One has become an Associate of CIEALCASTw.e.f. 2nd December, 2025.
