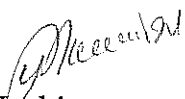
After aforesaid acquisition, the equity shareholding of Welspun Promoter Group in Welspun Corp Limited stands at 8,56,17,481 (32.56%).

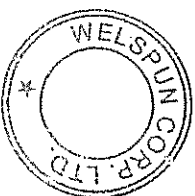
