Sub.: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations')

Pursuant to Regulation 30 of the Listing Regulations, we inform you that the Company has received Order dated January 27, 2026 from Office of the Commercial Tax Officer, Chennai South, Tamil Nadu, levying penalties of Rs.1,05,40,655/- for F.Y. 2020-2021 and Rs.50,35,342/- for F.Y. 2021-2022 in respect of show cause cum demand order against erstwhile Shriram City Union Finance Limited (which was amalgamated with the Company w.e.f. April 1, 2022).

These penalties had been imposed in accordance with Section 74 of the Central Goods and Service Tax Act, 2017 read with the Tamil Nadu Goods and Service Tax Act, 2017 ('TNGST Act 2017') and the Integrated Goods and Services Tax Act, 2017 ('IGST Act, 2017').
