Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that Nagreeka Exports Limited (Scrip Code: 521109) has remitted the fine levied by NSE Limited for non-compliance under Regulation 29(3) of the SEBI (LODR) Regulations, 2015, as communicated by your office vide email dated 20.11.2025.
