4	The Operating Segments have been identified on the basis of the business activities carried on by the company. The Company is operating in two segments i.e. Investments/Financial Segment and Real Estate Segment. Hence, as per Indian Accounting Standard 108, the Company made 'Segment Reporting' for operating segments as per annexure.
5	The Government of India has consolidated 29 existing labour legislations into unified framework comprising four labour codes namely; the Code of Wages, 2019, the Code on Social Security, 2020, the Industrial Relations Code, 2020 and the Occupational Safety, Health and Working Conditions Code, 2020 (collectively referred to as the "Codes"). The Ministry of Labour & Employment notified Central Rules on 8th May, 2026 however State Rules are yet to be notified. The incremental impact of these changes assessed by the Company on the basis of the information available is not material. The Company continues to monitor the developments pertaining to Labour Codes and will evaluate impact, if any, on the measurement of liability to employee benefits.

	The figures for the quarter ended March 31 as reported in these financial results are the balancing figures between audited figures in respect of the full financial year and the published year to date figures upto 31st December.
8	The previous year/quarterly figures have been recast/regrouped/rearranged, wherever necessary to make them comparable.
9	The above financial results have been reviewed by the Audit Committee and thereafter approved and taken on record by the Board of Directors at their meetings held on 28th May, 2026. The Statutory Auditors of the Company have issued an Auditor Report with un-modified opinion on the above Financial Results.

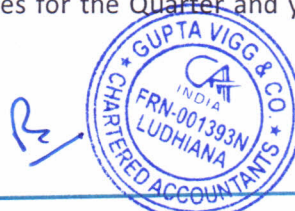

The respective Board of Directors of the Holding Company and its associates are responsible for overseeing the financial reporting process of the Holding Company and its associates.

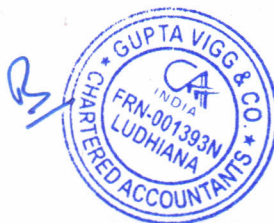
Auditor's Responsibilities

Audit of the Consolidated Financial Results for the year ended March 31, 2026

- Obtain sufficient appropriate audit evidence regarding the Annual Standalone Financial Results/ Financial Information of the Holding Company and its associates to express an opinion on the Annual Consolidated Financial Results. We are responsible for the direction, supervision and performance of the audit of financial information of such entities included in the Annual Consolidated Financial Results of which we are the independent auditors.

Materiality is the magnitude of misstatements in the Annual Consolidated Financial Results that, individually or in aggregate, makes it probable that the economic decisions of a reasonably knowledgeable user of the Annual Consolidated Financial Results may be influenced. We consider quantitative materiality and qualitative factors in (i) planning the scope of our audit work and in evaluating the results of our work; and (ii) to evaluate the effect of any identified misstatements in the Annual Consolidated Financial Results.

We communicate with those charged with governance of the Holding Company and such other entities included in the Consolidated Financial Results of which we are the independent auditors regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

That Financial Statement has been audited/reviewed, as applicable, by other auditors whose report has been furnished to us by the management and our opinion and conclusion on the statement, in so far as it relates to the amounts and disclosures included in respect of this associate, is based solely on the report of the other auditors and the procedures performed by us as stated under Auditor's Responsibilities section above.
- Our report on the Statement is not modified in respect of the above matter with respect to our reliance on the financial information certified by the Management.
