28-year-old interior designer arrested for harassing 14-yr-old girl in south Delhi

New Delhi: A 28-year-old interior designer was arrested on Tuesday for allegedly harassing a 14-year-old girl in south Delhi's Neb Sarai. According to the girl's family, when the girl was returning after dropping her younger brother at a nearby tuition centre around 5.30pm, the man, who was riding a scooter, suddenly approached her and tried to persuade her to accompany him. "He told her to sit with him for 10 minutes and kept repeatedly saying, 'Come with me,'" the girl's uncle alleged. The girl, who was alone at that time, was shaken and became anxious due to the incident, immediately returned home and informed her fa-

milily about it. The uncle claimed that the man also rode around their residential lane three-four times, making the girl feel extremely threatened. Alarmed by what happened, the family, along with other residents, approached Neb Sarai police station to demand urgent action against the man. Following the complaint, police registered a case. The man, who lives in Neb Sarai and works as an interior designer, was arrested on Tuesday. Police said investigation was underway to determine whether the suspect had a history of similar harassment incidents. **TNN**

3 held for setting DTC bus on fire

New Delhi: Police arrested three people, including two main accused, for allegedly setting a DTC bus on fire during an unrest that broke out in west Delhi's Nangloi area a fatal accident earlier this week. The main accused, Navesh Kumar (45) was identified through CCTV footage allegedly showing him setting the bus ablaze. Two others, Anurag and Deepu, were also arrested, while four more suspects were identified, taking the total arrests to seven. The violence erupted on Monday after two men died and several others were injured when two DTC buses, allegedly trying to overtake each other, collided. **TNN**

Two drug traffickers placed under preventive detention to break network

New Delhi: Delhi Police has invoked the stringent Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances (PITNDPS) Act against two alleged traffickers to weaken the network of active drug distributors operating in the city. Under the Act, a suspect can be preventively detained for up to 12 months without trial, making it significantly difficult for an alleged drug trafficker to get bail. The provision is approved by an advisory board that includes high court judges. The accused have been identified as Vijay Kumar, a 47-year-old resident of Nand Nagri, and Vikas, a 29-year-old from Najafgarh. Both have been lodged in Tihar Jail following detention orders. According to police, the

detention orders were issued on Feb 26 under Section 3(1) of the Act after authorities examined the criminal history and alleged continued involvement of the two men in narcotics trafficking. The proposals for preventive detention were prepared by the anti-narcotics task force (ANTF) of the crime branch and forwarded to the PITNDPS division of the revenue department under the Union finance ministry. "Kumar has a criminal history dating back to 1992 and is listed as a 'bad character' at Nand Nagri police station. He has been involved in around 50 criminal cases, including murder, snatchings, excise violations and drug trafficking," said DCP (ANTF) Rahul Alwal. Kumar's involvement in the narco-

tics trade first surfaced in 2007, when he was arrested in a case registered at Nand Nagri police station. More recently, he was arrested by ANTF last year, when 726 grams of heroin was found on him and his associates in a case registered by the crime branch. "Vikas entered the drug trade in recent years. He first came under the scanner in 2022, when he was arrested with 54 grams of amphetamine in a crime branch case that also involved provisions of Foreigners Act," said Alwal. "He was again arrested by ANTF last year, when 61 grams of MDMA was seized from him and his associates." Police said both were detained to prevent them from continuing their alleged involvement in drug trafficking.

Mall staffer mocked over body odour, case ordered

Noida: A man working at Spectrum Mall in Sector 75 has accused two colleagues of harassing him over body odour and making caste-based remarks. A special court on Wednesday admitted his complaint and directed that a case be registered. Additional district and sessions judge Somprabha Mishra observed that the applicant had provided specific details about the date, time and location of the alleged incident, as well as the identities of the accused. The court said this made it appropriate to treat the plea as a complaint. The provision allows an informant to approach a magistrate if the police fail to register a case despite a complaint. According to the order, a special Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act court will record the complainant's statement on April 10.

The complainant, Pawan Kumar, a Noida resident who works as a salesman at a kiosk in Spectrum Mall, told the court that two women, Aajra Siamwala and Shimoona, who run a nearby kiosk, had repeatedly mocked him with remarks related to his caste and body odour, causing him mental distress. Kumar alleged that the woman insulted him in front of others and physically assaulted him. He said staff members present at the mall intervened and separated them. He later filed a complaint with the police but no action was taken. **TNN**
