Sub: Passing of resolution through Postal Ballot

Pursuant to the resolution passed by the Board of Directors of M/s. NAVA Limited (the Company) on 7th November 2025, I (D. Renuka, Practicing Company Secretary) have been appointed as scrutinizer to receive, process and scrutinize the e-voting in respect of the Special Resolution (1 No.) as circulated in the postal ballot notice dated 7th November 2025.

To enable wider participation of shareholders, pursuant to the provisions of section 108 of the Companies Act, 2013 (the Act) and the rules framed thereunder and as required under the listing regulations, the company provided e-voting facility to its shareholders for the special resolution to be passed through postal ballot.

The Company through NSDL, (Service Provider) uploaded the special resolution together with the explanatory statement on which e-voting is required and for generating Electronic Voting Event Number (EVEN) by the service provider. The postal ballot notice was also placed on the website of the company and NSDL during the period of voting i.e. from Saturday, 15th November 2025 to Sunday, 14th December 2025.

In compliance with the MCA Circulars, this Postal Ballot Notice was sent only through electronic mode to those Members whose names appeared on the Register of Members / Register of Beneficial Owners as on Friday, November 07, 2025 ("Cut-Off Date") received from the Depositories and whose e-mail addresses were registered with the Company / Registrar and Transfer Agent / Depository Participants / Depositories.

I report that all votes cast by remote E-voting platform provided and administered by NSDL up to 5:00 P.M on Sunday 14th December 2025, being the last date fixed by the Company for e-voting, were considered for my scrutiny.

After the closure of the remote e-voting facility on Sunday, 14th December 2025 at 5:00 PM (IST), I unblocked and downloaded the e-voting data from the NSDL e-voting portal. I have diligently scrutinized the said data and finalized the results, which are tabulated below.
