Background of the Target Company

RGF Capital Markets Limited ("RGF" or the "Company") was incorporated on April 14, 1983, under the name of RGF Capital Markets Limited. Subsequently, the name of the Company was changed to Reskold Financial Services Limited and thereafter to RGF Capital Markets Limited on January 4, 1996. The Company is registered with the Reserve Bank of India ("RBI") as a Non-Banking Financial Company ("NBFC") under RBI Registration No. 15/0025, issued by the RBI, vide certificate dated February 21, 2008. The registered office of the Company is situated at 14, 2nd Floor, N. Road, Kolkata, West Bengal - 700001, India. The equity shares of the Company are listed on BSE Limited and the Calcutta Stock Exchange Limited.

Proposed Acquisition

As on the date of this Notice, the Acquirers collectively hold 2,08,65,708 fully paid-up Equity Shares of Rs. 1/- each in the Company, representing 13.91% of the paid-up equity share capital of the Company. The Acquirers have entered into a Share Purchase Agreement dated March 10, 2026 with the existing shareholders of the Company for the acquisition of 3,74,69,556 fully paid-up Equity Shares of Rs. 1/- each, representing 24.98% of the paid-up equity share capital and voting equity share capital of the Company, at an agreed price of Rs. 0.82/- per Equity Share, aggregating to Rs. 3,07,25,096. Further, the Board of Directors of the Company has approved on March 10, 2026, the proposed issue of 50,00,000 warrants on a preferential basis at an issue price of Rs. 1.00/- per warrant, of which the Acquirers propose to acquire up to 18,74,879 warrants, each warrant being convertible into one Equity Share of the Company, subject to receipt of the requisite regulatory and regulatory approvals. Pursuant to Regulations 3(1) and 4 of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011, as amended, the Acquirers have made a mandatory open offer to the public shareholders of the Company to acquire up to 3,90,40,000 Equity Shares, representing 36.00% of the paid-up equity share capital of the Company, at an offer price of Rs. 1/- per Equity Share, payable in cash.

Furthermore, following SEBI's approval of the Draft Letter of Offer dated 11, 2026, the Promoter Sellers of the Company have sold 1,18,55,656 Equity Shares, representing 7.99% of the Target Company's paid-up equity share capital, through open market transactions. As a result, the Acquirers are available for acquisition by the Acquirers under the SPA were reduced from 3,74,69,556 (24.98%) to 2,54,80,000 (16.98%). The Acquirers and the Company have agreed to remain bound by the SPA with respect to the remaining 2,54,80,000 Equity Shares.

Upon consummation of the proposed acquisition, the Acquirers would be classified as "Promoters" of the Company in accordance with the applicable law.

Rationale of Proposed Acquisition

The proposed acquisition is intended to acquire effective management and control of the Company and to continue its existing business as an NBFC. The Acquirers may explore diversification of business activities in future, subject to necessary approvals. The Acquirers intend to expand the Company's business activities as an NBFC, strengthen its Board, drive growth in business and add additional capital through suitable routes, with approval of the appropriate authorities.

RBI Approval

The RBI, vide letter dated September 24, 2026 (bearing reference No. KOL/DRO/15/0089/01/01/02/2026-27), has approved the proposed increase in shareholding of the Company with the Acquirers, subject to the condition that the Reserve Bank of India (Non-Banking Financial Companies - Acquisition of Shareholding or Control) Directions, 2002 dated November 26, 2002, bearing reference No. Master Direction/DRO/15/0089/01/01/02/2026-27, be applied to the proposed acquisition. The RBI has also approved the proposed change in management of the Company and has accorded its approval for the appointment of Mr. Nishad Jitendra Shah (Acquirer-1) and Mrs. Parvathi Nishad Shah (Acquirer-3) as the Acquirers of the Company, subject to the terms and conditions specified in the RBI approval letter and applicable regulatory and regulatory requirements.
