Sub: Clarification on Query Raised by the Exchange - XBRL Results for Quarter Ended 30th September, 2025-Reg.

Ref: Clarification sought on XBRL Results for the quarter ended 30th September, 2025 - EPS not mentioned in XBRL

With reference to the captioned subject and the clarification sought by the Exchange, we respectfully submit as under:

The Company had filed its XBRL financial results (both Standalone and Consolidated) through the **Integrated Filing Module vide NEAPS Application Nos. 127902 and 127903 on 14th November 2025**. However, due to an inadvertent typographical error, the Earnings Per Share (EPS) figures were reported under EPS for Discontinuing Operations instead of EPS for Continuing Operations in the said XBRL filings.

Subsequently, the Company received a discrepancy email dated 9th January 2026 from BSE Limited, advising the Company to rectify the aforesaid error and refile the XBRL results. **In compliance with the said communication, the Company has duly filed the revised XBRL financial results vide NEAPS Application Nos. 134370 and 134371 on 10th January 2026.**

The above error was unintentional and purely inadvertent in nature. We sincerely regret the same and assure the Exchange that due care shall be taken to avoid recurrence of such errors in future filings.

We request you to kindly take the above clarification on record.
