Dear Sir/Ma'am,

This is in continuation to the meetings of the Board of Directors (“**Board**”) of New Delhi Television Limited (“**Company**”) held on September 2, 2025, approving the offer and issue of equity shares of the Company (“**Equity Shares**”) on a rights basis to eligible equity shareholders of the Company (“**Issue**”), and our intimation dated September 8, 2025 regarding the outcome of the Board meeting held on September 8, 2025 approving the various terms of the Issue and the Letter of Offer.

In relation to the aforesaid Issue and pursuant to the finalization of the basis of allotment of the Issue, in consultation with the designated stock exchange i.e. BSE Limited, the Rights Issue Committee (“**Committee**”), by way of circular resolution passed today, i.e., October 9, 2025, *inter alia*, considered and approved the allotment of 4,83,53,450 Equity Shares at a price of ₹ 82 per Equity Share (including a premium of ₹ 78 per Equity Share) (“**Allotment**”).

Accordingly, pursuant to the above allotment, the paid-up equity share capital of the Company has increased from ₹ 25,78,85,068, comprising of 6,44,71,267 fully paid-up equity shares to ₹ 45,12,98,868, comprising of 11,28,24,717 fully paid-up Equity Shares of face value of ₹ 4 each.
