This is with reference to emails dated 12<sup>th</sup> June 2026 received from NSE and BSE regarding clarification/ confirmation sought on the recent news appeared in <https://www.moneycontrol.com> on 12<sup>th</sup> June 2026. In this regard, we hereby provide the following clarification on the aforesaid news item:

We categorically reject the allegations circulating on media basis an unverified account regarding the presence of infestation, allegedly on MAGGI noodles. We are yet to receive the complaint sample from the Complainant as the account is unreachable. A detailed representation, supported by all relevant facts, quality records from batch and market samples, test reports, has already been submitted to the competent authorities.

Nestlé India maintains stringent quality and food safety standards across its manufacturing operations. We remain fully transparent with the authorities and are confident that the facts and evidence will conclusively establish the truth of the matter.

We have performed our quality analysis on batch and market samples, for a comprehensive investigation to FSSAI Accredited lab and the report confirms with the quality standards including confirmation of absence of infestation of any nature.

Specific response on the clarification sought by you regarding the aforesaid Publication is provided hereunder:

The Company was made aware of this complaint through FSSAI basis a concern raised by unverified account holder on social media platform X and the Company as part of standard procedure sought for complaint sample for assessment multiple times. However, the account holder did not respond to the same. In the interim, as per standard process, the reference sample of the same batch was sent for testing to an independent FSSAI notified and NABL accredited lab which have found the reference sample to be free of any infestation. A detailed representation, supported by all relevant facts, quality records from batch and market samples, test reports, has already been submitted to the competent authorities.
