REPORTS ON THE AUDIT OF THE FINANCIAL RESULTS

OPINION

We have audited the accompanying half year and year-to-date standalone financial results of M/s Newjaisa Technologies Private Limited (the "Company") for the half year and year ended 31st march 2026 (the "Statement") attached herewith, being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations").

BASIS OF OPINION

We conducted our audit in accordance with the Standards on Auditing (SAs), as specified under section 143(10) of the Act. Our responsibilities under those standards are further described in 'the Auditors' Responsibilities for the Audit of the Financial Results' section of our report. We are independent of the Company, in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India (ICAI) together with ethical requirements that are relevant to our audit of the financial results under the provisions of the Companies Act, 2013, and rules thereunder, and we have fulfilled our ethical responsibilities in accordance with these requirements. We believe that audit evidence obtained by us is sufficient and appropriate to provide a basis for opinion.

KEY AUDIT MATTERS

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the standalone financial results for the year ended 31st March 2026. These matters were addressed in the context of our audit of the financial results as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

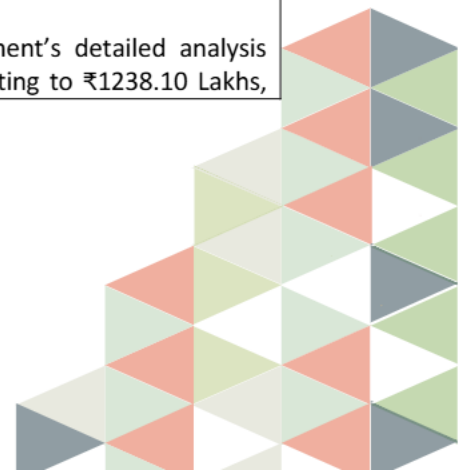

	<p>to Amazon's sudden exit from the refurbished electronics market in March 2025 and a rapid shift in customer demand toward higher-configuration. this matter is critical because the write-off accounts for 71% of the company's net loss of ₹1741.89 Lakhs, and it is included in "Purchases of Traded Goods"(COGS), which severely compressed gross margins from 30.29% to 6.45%.</p> <p>Given the materiality of the write-off (71% of loss), and the significant judgment involved in valuation, we determined this to be a key audit matter.</p>	<p>including category-wise details of systems, laptops, spare parts, and components, along with the ageing profile of the written-off inventory and the reasons for considering the items obsolete.</p> <p>We reviewed inventory ageing reports and slow-moving stock analysis to assess whether management's identification of obsolete inventory was reasonable. Management explained that the write-off mainly relates to old systems and spare parts that no longer have significant realizable value due to changing market requirements. With the increasing use of high-performance applications, demand has shifted towards higher-configuration machines, reducing the commercial relevance of older inventory. Management also stated that the market prices of older models, such as i3 and i5 configurations, have declined significantly as customers now prefer higher-performance systems.</p>
2	<p>The Company's revenue from operations faced a sharp 38.35% decline, dropping from ₹6566.00 Lakhs in FY25 to ₹4048.82 Lakhs in FY26, Management attributed this disruption due to Amazon India entirely discontinuing its refurbished electronics marketplace in March 2025 (which previously drove 60% of the company's revenue), the natural time lag required to set up alternative B2B and direct distribution channels, In response, the company made a strategic shift into a multi-channel model spanning B2B corporate sales, distribution partnerships, Refurbishment-as-a-Service, and direct website sales. We identified this as a key audit matter because shifting to diverse revenue streams introduces complex revenue recognition timings under AS-9, critical cut-off procedures, and fresh customer concentration and receivable recoverability risks.</p>	<p>Our audit approach included reviewing public news reports related to Amazon's exit and checking the company's Seller Central accounts to confirm the loss of marketplace revenue. We also examined confirmed B2B purchase orders, email communications, and delivery timelines to verify the status of the new business pipeline. In addition, we reviewed the updated revenue recognition policies in line with AS-9 to ensure that B2B sales are recognized at the time of dispatch or delivery and that service contracts are properly structured.</p> <p>Based on our Assessment, we concluded that the decline in revenue is mainly due to Amazon's exit. Management responded quickly by shifting to new business channels within the same financial year. However, the long-term sustainability and the ability to achieve earlier revenue levels will depend on successful execution, although the current accounting policies for these new revenue streams are in line with AS-9.</p>

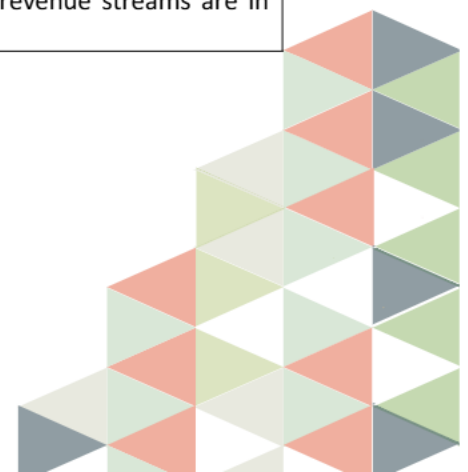
