Sub: Change in Registrar and Share Transfer Agent.

In terms of Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform you that consequent to the completion of tenure, the competent authority has accorded change in Registrar and Share Transfer Agent (RTA) of the Company from M/s MUFG Intime India Pvt Ltd to M/s Alankit Assignment Ltd.

1	Reason for appointment	M/s MUFG Intime India Pvt Ltd had been appointed as RTA of the Company from FY 2022-23 to FY 2025-26. As the tenure of the aforesaid RTA is going to end on 31.03.2026, M/s Alankit Assignment Ltd was appointed as the RTA of the Company on the basis of RFP floated for the same.
2	Date on which above would become effective	The effective date of change of RTA will be intimated to the Stock Exchanges in due course of time.

The formalities for change of RTA including documentation, execution of agreement, shifting of electronic connectivity and transition of data is under process. Once the shifting of data is complete, the tripartite agreement as required under Regulation 7 of SEBI (LODR), 2015 shall be signed and will be placed before the Board along with submission to the Stock Exchanges.
