Appeal has already been filed for the said matter and is pending for decision.</p> <p>There is no material impact on financial, operation or other activities of the Company due to this show cause notice and amount of demand. The impact will be limited to the extent of final tax liability as may be ascertained along with interest and penalty, if any.</p>
