Details of the violation(s)/contravention(s) committed or alleged to be committed	The Office of the Commissioner (Appeals) CGST - Jodhpur vide its order dated 27 February 2026 allowed the Appeal filed by the Company and set aside the earlier order of the Asst Commissioner CGST – Jodhpur. The GST Department has earlier vide its order of Asst. Commissioner, disallowed the ITC aggregating INR 50,50,133/- and imposing penalty of equivalent amount of INR 50,50,133/- on the Company which were alleged to be wrongly availed in TRAN-01 in contravention of section 140(3) and 142(11)(c) of the CGST Act 2017 read with applicable rules.
Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible	Since the Appeal of the Company is allowed, the Company is now not required to make payment of disallowed amount of INR 50,50,133/- together with equivalent amount of penalty and interest. The matter is closed and the disallowed amount and interest & penalty thereon is set aside.
