# नगरपालिका का ईओ व परिवहन विभाग का उपनिरीक्षक रिश्त लेते गिरफ्तार

जयपुर, 13 नवंबर (भाषा)।  
प्रशाचर निरोधक ब्यूरो (एसीबी) के दो अलग-अलग दलों ने कार्रवाई करते हुए नगरपालिका के मुख्य कार्यकारी अधिकारी (ईओ) और परिवहन विभाग के उपनिरीक्षक व उड़न दस्ते के गाड़ों को कथित तौर पर रिश्त लेते हुए गिरफ्तार किया।

ब्यूरो के महानिदेशक भगवान लाल सोनी ने शुक्रवार को बताया कि ब्यूरो (एसीबी) के एक दल ने शुक्रवार को झुंझुनू जिले के चिड़ावा नगरपालिका के मुख्य कार्यकारी अधिकारी अनिल कुमार चौधरी को तीन लाख रुपये की कथित रिश्त लेते हुए हाथों गिरफ्तार किया है। उन्होंने बताया कि आरोपी मुख्य कार्यकारी अधिकारी अनिल कुमार चौधरी की पत्नी के दो भूखंडों के 90ए की कार्रवाई कर पट्टा जारी करने की एवज में 12 लाख रुपये की रिश्त की मांग कर रहा था। उन्होंने बताया कि आरोपी को उनके आवास से तीन लाख रुपये की कथित रिश्त लेते रहे हाथों गिरफ्तार किया गया है। एक अन्य कार्रवाई में ब्यूरो की कोटा ईकाई ने परिवहन विभाग की चैक पोस्ट रतनपुर बाई, डूंगरपुर पर परिवहन विभाग के चैक पोस्ट प्रभारी उपनिरीक्षक छान मेघवाल व उड़न दस्ते के गाड़ जितेंद्र सिंह, महिपाल सिंह व पूरण सिंह व दत्ताल नेपाल सिंह को गिरफ्तार किया है। मौके पर चैक पोस्ट व तैनात कर्मियों को वाहन चालकों को रोक कर तलाशी में अवैध रूप से वसूली 2 लाख 69 हजार 840 रुपये की राशि बरामद की गई। उन्होंने बताया कि एसीबी को परिवहन विभाग की रतनपुर चैक पोस्ट, जिला डूंगरपुर पर अवैध वसूली की अनेक शिकायतें लगातार मिल रही थी। इसी के तहत आरोपियों को वाहन चालकों को रोक कर एन्ट्री के नाम पर रिश्त लेते रहे हाथों गिरफ्तार किया गया है। परिवहन विभाग के कुछ कर्मियों के रिश्त राशि के साथ फरार होने की जानकारी भी मिली है। एसीबी द्वारा प्रशाचर निवारण अधिनियम 1988 के अंतर्गत प्रकरण दर्ज कर आगे की कार्रवाई की जा रही है।

मप्र में पिकअप वाहन पलटने से 10 की मौत, 20 घायल  
शिवपुरी (मध्य प्रदेश), 13 नवंबर (भाषा)।

मध्य प्रदेश में शिवपुरी जिले के पोहरी के पास शुक्रवार रात पिकअप वाहन के पलटने से इसमें सवार तीन महिलाओं सहित 10 लोगों की मौत हो गई और 20 अन्य घायल घायल हो गए। शिवपुरी जिले के पुलिस अधीक्षक राजेश सिंह चंदेल ने बताया कि घटना शुक्रवार रात करीब सवा सात बजे उस वक्त हुई, जब संबंधित लोग इस वाहन से राज्य के श्योपुर जिले के उनावद से अपने गांव डोडी वापस लौट रहे थे। उन्होंने कहा कि इस हादसे में छह लोगों की घटनास्थल पर ही मौत हो गई और चार लोगों ने उपचार के दौरान दम तोड़ दिया। चंदेल ने बताया कि घटना के तुरंत बाद घायलों को पोहरी व शिवपुरी जिला अस्पताल ले जाया गया।

मध्य प्रदेश में पुलिस के विशेष कार्य बल (एसटीएफ) ने मुरैना जिले के अम्बाह करखे में तीन गोदामों पर छापा मार कर सिंथेटिक दूध बनाने में कथित तौर पर इस्तेमाल होने वाले 21 लाख रुपये कीमत के रासायनिक पदार्थ जब््त किए हैं। एक अधिकारी ने बताया कि बृहस्पतिवार रात को अम्बाह करखे में सोनू अग्रवाल (35) के गोदामों से शैणू, कारिंटक सोडा और डिजैट के बोरे बरामद किए गए। अग्रवाल हाल ही में दूध में मिलावट के आरोप में तीन माह जेल में गुजारने के बाद जमानत पर बाहर आया है। खाद्य सुरक्षा अधिकारी रेखा सोनी ने बताया कि मिलावटी दूध का निर्माण और बेचने के आरोप में अग्रवाल को पिछले साल 19 जुलाई को राष्ट्रीय सुरक्षा कानून (एनएसए) के तहत पकड़ा गया था। उन्होंने बताया कि गोदामों पर छापे के बाद अग्रवाल फिलहाल फरार हो गया है। पुलिस उसकी तलाश कर रही है। सोनी ने बताया कि आरोपी अग्रवाल मुरैना के अलावा मालियर, भिंड और श्योपुर में मिलावटी सिंथेटिक दूध की आपूर्ति करता था। आरोपी के गोदामों से एक हजार बोरी डिजैट बरामद किया गया है। दूध की मिलावट कर उसकी आपूर्ति करने वालों के खिलाफ अभियान चलाया गया है। दीपावली के त्योहारी सीजन में मिलावटी दूध और मावे का मिटाई बनाने में बड़े पैमाने पर इस्तेमाल किया जाता है।
