Item No. 1: RE-APPOINTMENT OF MRS. DIMPLE DEEPAK GERUJA (DIN: 07797357) AS AN INDEPENDENT DIRECTOR OF THE COMPANY

Mrs. Dimple Deepak Geruja was appointed as an Independent Director of the Company under the provisions of the Companies Act, 2013, vide resolution passed by the Members at the Annual General Meeting held on September 29, 2017. As per the said resolution, the term of appointment of Mrs. Dimple Deepak Geruja was up to April 18, 2022.

Pursuant to the provisions of Section 149 and other applicable provisions of the Companies Act, 2013, an Independent Director shall hold office for a term up to five consecutive years on the Board of a Company, and shall be eligible for re-appointment on passing of a special resolution by the Company and disclosure of such appointment in Board's report.

The Nomination and Remuneration Committee (NRC) of the Board of Directors, has evaluated the performance of Mrs. Dimple Deepak Geruja, as Independent Director based on the performance evaluation parameters which include level of participation in decision making process, understanding of Company's business and industry, ensuring adequacy and functionality of vigil mechanism, communicating inter-se with Board members and senior management etc. On the basis of the report of performance evaluation and having regard to his qualifications, knowledge, rich experience and expertise the NRC has recommended re-appointment of Mrs. Dimple Deepak Geruja, as an Independent Director for a second term.



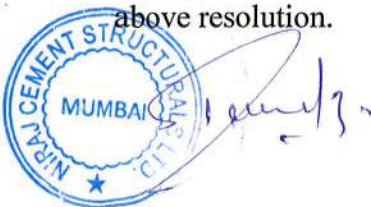
