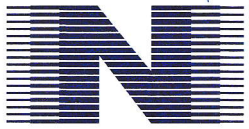

5	Action taken by Listed Company/ Intermediary/ Fiduciary	The Company has taken following actions: a. Sought explanation from Mr. MOHIT KUMAR VIJAYVERGIA in writing for committing the aforesaid violation; and b. Issued a warning letter to him to strictly adhere as per the statutory requirements henceforth and levied a penalty of Rs. 2000/- for contra trade after taking into account the relevant facts and in terms of the provisions of Company’s Code of Conduct to Regulate, Monitor and Report Trading by Insiders
6	Reasons recorded in writing for taking action stated above	Following points have been considered while taking action in terms of the Company’s Code of Conduct: 1. Mr. Mohit Kumar Vijayvergia was not in possession of any Unpublished Price Sensitive Information (“UPSI”). 2. Mr. Mohit Kumar Vijayvergia conducted the trade after the opening of Trading Window. 3. Such violation was first instance and there was no history of earlier violation on the part of Mr. Mohit Kumar Vijayvergia

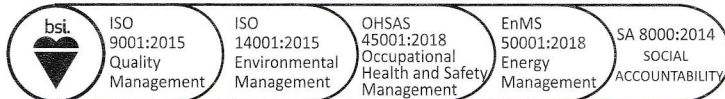

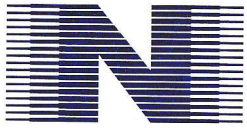

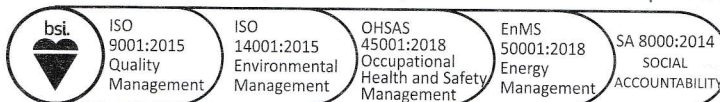
