In compliance of Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform the following:

Neyveli Uttar Pradesh Power Limited (NUPPL), a Joint Venture Company of NLC India Limited and U.P. Rajya Vidyut Utpadan Nigam Limited with equity shareholding in the ratio of 51:49 respectively, is establishing 3 X 660 MW Ghatampur Thermal Power Plant at Ghatampur, Uttar Pradesh.

The Company was allotted the Pachwara South Coal Block (9 MTPA), Dumka District in the State of Jharkhand vide allotment order no. 13016/26/2004-CA-I/CA- III(Pt) (Vol.II), dated 03.10.2016 by the Ministry of Coal, GoI, to meet the fuel requirement of 3 X 660 MW Ghatampur Thermal Power Plant. The coal block was previously unexplored and was explored by NUPPL through detailed drilling across the entire block. The said coal block has an extractable coal reserve of 264.84 million tonnes. The normative capacity of the mine is 9 million tonnes per annum and the average grade of coal is G10.

In terms of Regulation 30 & 51 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations,2015 (LODR), we are pleased to inform that Pachwara South Open Cast Project initial mining operations have been commenced on 19<sup>th</sup> December 2025.
