### INFORMATION ON TDS CERTIFICATE FOR THE DIVIDEND FOR FY 2024-25

As you are aware, Nocil Limited ("the Company") has paid dividend to all its shareholders on and from August 14<sup>th</sup>, 2025 upon its declaration at the 63rd Annual General Meeting of the Company held on Thursday, August 7<sup>th</sup>, 2025.

Pursuant to the Income-tax Act, 1961, as amended by the Finance Act, 2020, the Company has deducted tax at source (TDS), at the prevailing rates, while making payment of the above dividend only in respect of those shareholders whose dividend income exceeded the threshold limit and where no valid exemption form was provided. Pursuant to this, the Company has deducted TDS from the final dividend payment made to you. The Company is required to furnish the requisite certificate for TDS in Form No. 16A. Accordingly, the necessary certificate in respect of the TDS is being provided at the link in this communication.

You are requested to download your TDS certificate in respect of the aforesaid TDS by visiting URL: <https://ris.kfintech.com/clientservices/tds>. You can validate the login by entering your Income Tax Permanent Account Number (PAN) and DP ID/Client ID or Physical Folio details.
