# ন্যায্য দাম না পেয়ে দিশেহারা আলু চাষীরা, সংকটে পূর্বস্থলীর খিতপুর

প্রসন্নজিত দেবনাথ, পূর্বস্থলী, ১৩ ফেব্রুয়ারি : পূর্বস্থলী দু'নম্বর ব্লকের কালেক্টারতা এক পঞ্চায়েতের খিতপুর এলাকায় এবার চরম সংকটে পড়ছেন আলু চাষীরা। মাঠে ইতিমধ্যেই আলু উঠতে শুরু করেছে, কিন্তু বাজারে ন্যায্য দাম না পেয়ে গভীর হতাশায় ভুগছেন তারা। দিন দিন সারের দাম বৃদ্ধি পাচ্ছে, চাষের অন্যান্য খরচও বেড়েই চলেছে-কিন্তু সেই অনুপাতে বাড়ছে না আলুর দাম। ফলে চাষীদের মাথায় হাত পড়ছে। স্থানীয় চাষীদের দাবি, বর্তমানে প্রতি বস্তা আলুর দাম বাজারে ২২০ থেকে ২৪০ টাকার মধ্যে যোরফোরা করছে। অথচ এক বিশেষ জমিতে আলু চাষ করতে মোট খরচ পড়ে প্রায় ২৭ থেকে ২৮ হাজার টাকা। শুধু সার কিনতেই খরচ হচ্ছে প্রায় ২২০০ টাকা। এর সঙ্গে যোগ হচ্ছে বীজ, কীটনাশক, শ্রমিক মজুরি, সেচ ও পরিবহন খরচ। সব মিলিয়ে বিপুল ব্যয়ের বোঝা বহিতে হচ্ছে কৃষকদের। ফলন ভালো হলেও সঠিক দাম না পাওয়ায় সেই লাভের মুখ আর দেখা হচ্ছে না। চাষীদের কথায়, গত বছর আলুর দাম তুলনামূলকভাবে ভালো ছিল, ফলে কিছুটা হলেও লাভের মুখ দেখেছিলেন তারা। কিন্তু এবছর পরিস্থিতি সম্পূর্ণ উল্টে। উৎপাদন খরচ বেড়েছে কয়েকগুণ, অথচ বাজারের তালানিতো। অনেকেরই বলছেন, এই দামে আলু বিক্রি করলে চাষের খরচই উঠবে না, লাভ তো দূরের কথা। ফলে ঋণের বোঝা



আরও বাড়বে বলেই আশঙ্কা করছেন তারা। খিতপুর এলাকার বহু পরিবারই আলু চাষের ওপর নির্ভরশীল। এই ফসল থেকেই সারা বছরের সংসার চালানোর আশা করেন তারা। কিন্তু একেবারে বাজার পরিস্থিতি তাদের চরম অনিশ্চয়তার মুখে ঠেলে দিয়েছে। হতাশ কৃষকদের বক্তব্য, যদি দ্রুত ন্যায্য মূল্য নিশ্চিত না করা হয়, তাহলে ভবিষ্যতে আলু চাষ থেকে সরে আসার কথাও ভাবতে বাধ্য হবেন অনেকেই। চাষীদের দাবি, প্রশাসনের তরফে অবিলম্বে হস্তক্ষেপ করে আলুর ন্যায্য দাম নিশ্চিত করতে হবে। না হলে এভাবে লোকসান গুনতে গুনতে একসময় কৃষক সমাজ আরও বড় সঙ্কটের মুখে পড়বে- এমন আশঙ্কাই ঘুরপাক খাচ্ছে পূর্বস্থলীর মাঠে।
