This difference has arisen on account of allotment of 5,350 equity shares under the ESOP Scheme. While the Company, when listed on NSE, had obtained in-principle approval for the said ESOP Scheme, pursuant to its migration to the Main Board of NSE and BSE, a separate in-principle approval from BSE was required and has since been obtained. Pending completion of the corporate action for the said 5,350 equity shares, these shares are reflected in the paid-up share capital but not in the listed share capital, thereby resulting in a temporary variance.
