

वीज ग्राहकांनी मोजले अतिरिक्त १०७९ कोटी

● मुंबई । प्रतिनिधी

महावितरण आणि महानिर्मिती कंपनीमधील वीज कारापोटीच राज्यातील वीज ग्राहकांनी गेल्या ६ महिन्यांत १०७९ कोटी रुपये अतिरिक्त मोजले आहेत. युनिटमागे दीड रुपया जास्त मोजून त्याचा भुर्दंड ग्राहकांवर लादण्यात आला आहे. त्यामुळे राज्य वीज नियामक आयोगाने हे पैसे मंजूर करू नयेत, अशी मागणी ठाणे बेलापूर इंडस्ट्रीज असोसिएशनचे प्रतिनिधी अशोकपेंडसे यांनी केली आहे. महावितरणने आयोगापुढे वीजदर प्रस्तावासाठी मांडलेल्या जनसुनावणीदरम्यान ते बोलत होते.

पेंडसे म्हणाले, सहा महिन्यांमध्ये ४१९६ दशलक्ष युनिट इतकी महागडी वीज महानिर्मितीकडून विकत घेतली. त्याच वेळी इतर स्वस्त वीजनिर्मिती करणाऱ्या कंपन्यांकडून वीजखरेदी केली नाही. म्हणून आयोगाने ग्राहकांवर हा भुर्दंड लादू नये. सरकारी कंपनी म्हणून महावितरण महानिर्मितीची किती दिवस पाठ्याखण करणार आहे?

त्याऐवजी महानिर्मितीने आता आपली महागडी वीज राज्याबाहेरील ग्राहकांना विकण्याची वेळ आली आहे. दिल्लीमध्ये एनटीपीसी इझर कंपनीची महागडी वीज हरियाना आणि पंजाबला विकण्यासाठी सर्वतोपरी प्रयत्न केले. त्याच वेळी ग्राहकांवर स्थिर आकराचा



बोजा पडणार नाही, याचीही काळजी घेण्यात आली. महाराष्ट्रातही महानिर्मितीने अशी पावले उचलण्याचा विचार करण्याची वेळ आली असल्याचे त्यांनी स्पष्ट केले. देशभरामध्ये सरासरी वीज खरेदी खर्चांमध्ये घट होत आहे; पण महावितरणच्या आगामी वर्षासाठीच्या वीज खरेदीमध्ये घट होण्याऐवजी त्यामध्ये वाढ प्रस्तावित केली आहे. अशा वेळी महानिर्मितीच्या वीजखरेदीच्या कारावर कुठेही नियंत्रण येणे गरजेचे आहे. महाराष्ट्राची विजेची मागणी ही १८ हजार मेगावॉट इतकी आहे; पण वीजखरेदी करामुळे महावितरणला मिळणारी अतिरिक्त ८ हजार मेगावॉट इतकी वीज न वापरताच बँकेला झूज करावी लागते. म्हणजे वीज संचातून वीजनिर्मिती कमी करावी लागते. त्यामुळेच या बँकेला झूज विजेचा ४ हजार कोटी रुपयांचा अतिरिक्त बोजा ग्राहकांवर येत असल्याचे महाराष्ट्र वीज ग्राहक संघटनेचे प्रताप होगाडे यांनी म्हटले आहे.
