This is to inform you that a designated person of the Company has acquired/purchased shares of the Company and, being a designated person, the transaction is covered under Regulation 7(2) of the SEBI (Prohibition of Insider Trading) Regulations, 2015, read with the applicable provisions relating to automation of continual disclosures/system-driven disclosures under the said Regulations.

The said transactions are covered under the automatic/system-driven disclosure mechanism, but certain transactions undertaken by Mr. Saurabh Goyal, Promoter of the Company, on 10 September 2026 and all transactions undertaken by him thereafter are not appearing on the stock exchange platform under the automatic/system-driven disclosure mechanism. Accordingly, the Company is submitting the disclosures manually under Regulation 7(2) of the SEBI (Prohibition of Insider Trading) Regulations, 2015.

However, in view of the fact that the aforesaid transactions are not appearing on the stock exchange platform under the automatic/system-driven disclosure mechanism, the Company is submitting the disclosures manually as an abundant precaution and to ensure that the requisite disclosures are duly made and placed on record.
