**Sub: Rumour Verification: Intimation under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”) – Clarification on news articles published in mainstream media**

Pursuant to Regulation 30(11) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), and with reference to certain news reports and articles, we would like to provide the clarification on the following articles:

1. **“SMVDNSH Governing Body reviews hospital functioning, future plan”** dated March 27, 2026 published in Daily Excelsior and on its online portal (dailyexcelsior.com).
2. **‘आधुनिक सुविधाओं से लैस होगा कटड़ा SMVD नारायणा सुपरस्पेशियलिटी अस्पताल, गवर्निंग बाडी की 71वीं बैठक में लिया फैसला’** dated March 26, 2026, published on the online portal of Jagran (jagran.com).

The Company had on March 28, 2025 disclosed to the Stock Exchanges under Regulation 30 of the Listing Regulations, the execution of an agreement between its wholly owned subsidiary, Narayana Vaishno Devi Specialty Hospitals Private Limited (NVDSHPL) and Shri Mata Vaishno Devi Charitable Society.

In furtherance of the above disclosed arrangement, NVDSHPL has now executed a Business Transfer Agreement (BTA) with Shri Mata Vaishno Devi Charitable Society to give effect to the previously announced transition of the Hospital to the Society to take effect from April 1, 2026, while NVDSHPL shall provide only supervisory oversight role upto 2033. Accordingly, the reference in the aforesaid media reports pertains to the implementation of an arrangement that has already been disclosed by the Company and does not constitute a new material event.
