NATCO bullish on US markets

The consolidated revenues of Hyderabad based **NATCO** Pharma Limited for the year ended 31st March, 2011 amounted to Rs. 483 Crores against Rs. 475 Crores during the year ended on 31st March, 2010. But for the sale of two of its Pharmacy out-lets in the USA (which accounted for an aggregate revenue base of around Rs. 90 Crores), the revenues would have been much higher.

The Company recorded a net consolidated profit of Rs. 53.51 Crores for the year 2010-11 against Rs. 48.72 Crores for the year 2009-2010, recording an increase of nearly 10%.

During the year, the Company's revenues from API division grew by 20% (from Rs. 89 Crores to Rs. 106 Crores) and the company's exports of finished dosage pharmaceutical formulations grew by 114% (Rs. 51 Crores during the year 2010-11 against Rs. 24 Crores during the last year).

The Company has drawn up elaborate plans to enter US markets, having acquired FTF (first to file with 180 days marketing exclusivity) status for three of its ANDAs – Lanthanum Carbonate, Lenalidomide, and Oseltamivir Phosphate. The company's Para IV challenges target an existing brand sale of around US \$ 6 Billion. The Company has filed 18 ANDAs, out of which four are Para IV challenges and three are with FTF status.
