The forces that played an important role in locating the SIMI members and gunning them down were the district police force, Counter Terrorist Group (CTG) and Anti Terrorist Squad (ATS). The encounter spot is located near Eimkhedi village under Gunga police station area.

Taking serious note of the jailbreak, the DIG Jail, Jail Superintendent, Deputy Jail Superintendent and Assistant Superintendent have been suspended. ADG Jail has been removed. Moreover, Chouhan said that investigation is going on. Investigation of the incident has been handed over to the Former DGP Nandan Dubey. After the investigation, stringent action will be taken against the culprits.

Chouhan said the decision has been taken to get the investigation done by the NIA after the discussion with the Union Minister for Home Rajnath Singh. This decision has been taken to find out any international reason behind this incident. Moreover, decision has been taken to post Sudhir Shahi on the post of ADG jail.

In the evening, the Chief Minister declared that Rs 5 lakh for the marriage of slain Head Constable's daughter has been sanctioned, apart from Rs 10 lakh as ex-gratia besides all possible help to the family. This is the second major jailbreak by operatives of SIMI in three years after the sensational escape by seven members of the group from a jail in Khandwa in Madhya Pradesh in 2013.

The Union Home Ministry has sought a detailed report from the State Government on the jailbreak and whether there was any lapse on the part of the jail administration and the steps taken to check such incidents.

The central security agencies were particularly anxious as four of the seven SIMI activities, who escaped from a jail in Khandwa on October 1, 2013, could be arrested only after three years and during the period of their hiding, they were involved in multiple incidents of terror and a bank robbery. While in hiding, the SIMI men were allegedly involved in terror activities in several States including Madhya Pradesh, Andhra Pradesh, Telangana, Karnataka, Tamil Nadu, Maharashtra, Uttarakhand and Uttar Pradesh.

"A 45-metres long tunnel was constructed to aid outflow of the lake downstream. We have also installed a mechanical gate to control the discharge," said Lieutenant Colonel Bharat Lal Shrestha, who led the Nepal Army team.

"Because of the wind, snow and thin air, we could work only two or three hours a day. It was a challenging task," he said.

The surface area covered by the lake expanded from 0.4 to 1.01 square km between 1984 and 2009, triggering concerns that it may breach its banks and flood villages downstream.

Experts say that a flood+ would have a catastrophic impact on the lives of more than 50,000 people living in nearby villages and even in southern districts of the country. As part of the project, early warning systems have also been installed in villages downstream.

"It is a serious issue. First SIMI activists fled the Khandwa Jail. Now they have fled from Bhopal jail. I have been reiterating that RSS activists and other similar organisations are behind the anti-Muslim riots in the country. It should be probed whether there is someone behind this or not," Singh told reporters.

Strongly attacking Opposition parties for raising doubts on the "police encounter", the BJP urged all the parties "to shun vote bank politics" and hit out at the Congress for shedding "tears for terrorists" and lowering morale of security forces engaged in a difficult battle on borders.

Describing the eight alleged SIMI members as terrorists, BJP spokesperson GVL Narasimha Rao wondered as to why Opposition parties seek to defend "terrorists, gangsters and Kashmiri separatists" and stand with those wanting "Bharat ki barbadi". Rao said those criticizing "the successful police action" in Madhya Pradesh were "usual suspects" like Congress, CPI, CPM, AAP, JD(U), RJD etc, "ready to lower morale of security forces."

The BJP leader said Opposition parties "sympathy" was on account of their "vote bank politics" and "perverse sec-

ularism intended to appease a section of people". In this context, Rao referred to what he called Congress president Sonia Gandhi "shedding tears for those killed in Batla encounter" and Rahul's "questioning surgical strikes".

The Congress does not have time to pour over the "mutilated body of an Army jawan" and "that is what I call 'khoon-ki-dalali'", Rao said pointing a finger at Rahul who had earlier thrown the same barb at Prime Minister Narendra Modi after the surgical strikes by the Indian Army.

"Looking at the way the Congress is politicising the encounter, and that too concerning the particular group or organisation, is a matter of concern. The Congress seems to raise concern only when LeT terrorists are killed and when SIMI activists who are convicted and involved in jailbreak are concerned. The Congress Party springing to their defence raises curiosity," he said. Explaining the police action he said based on a tip-off from the local people police located the escaped "terrorists" and succeeded in killing them. Rao said all eight SIMI members were charged with heinous crimes.

CPI-M's Brinda Karat termed the official version of the incident as "highly dubious and suspicious". She said the versions of State Government and police were "contradictory". "Therefore, to get to the truth, it is essential to have an independent probe.
