Summary of Proceedings of 53rd Annual General Meeting of Oriental Aromatics Limited held on 21st August, 2025:-

I. Date , time and Venue of the Meeting:

The 53rd Annual General Meeting of Oriental Aromatics Limited (the 'Company') was held on Thursday, 21st August, 2025 at 11:00 a.m. through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM"), in compliance with the applicable provisions of the Companies Act, 2013, Circular No. 20/2020 dated May 05, 2020, Circular No. 02/2021 dated January 13, 2021 and Circular No. 10/2022 dated December 28, 2022, Circular No. 09/2023 dated September 25, 2023 and Circular No. 09/2024 September 19, 2024 (collectively referred to as 'MCA Circulars') and Securities and Exchange Board of India ("SEBI") Circular no. SEBI/HO/CFD/ CMD1/CIR/P/2020/79 dated May 12, 2020, Circular no. SEBI/HO/CFD/CMD2/CIR/P/2021/11 dated January 15, 2021, Circular No SEBI/HO/CFD/CMD2/CIR/P/2022/62 dated May 13, 2022 , SEBI/HO/CFD/PoD2/P/CIR/2023/4 dated January 5, 2023, Circular No SEBI/HO/CFD/CMD2/CIR/P/2023/167 dated October 7, 2023 and Circular No. SEBI/HO/MIRSD/ MIRSD-PoD-1/P/CIR/2024/143 dated October 4, 2024. The deemed venue of the AGM was the Registered Office of the Company situated at 133, Jehangir Building, 2nd Floor, Fort, Mumbai-400001.

II. Brief Details of items deliberated and result thereof:

Ms. Kiranpreet Gill, Company Secretary welcomed the members present in the 53rd Annual General Meeting, and introduced Mr. Dharmil A. Bodani, Chairman and Managing Director and requested him to chair the proceedings of the Meeting. Thereafter, Mr. Dharmil A. Bodani chaired the proceedings of the meeting and welcomed each one attending the meeting and extended gratitude for continued trust and unwavering support.

The number of shareholders as on the cut-off date i.e. 14th August, 2025 was 26,694. Total 51 shareholders attended the meeting through video conferencing.

The requisite quorum being present, the meeting was called to order. The Chairman requested the Company Secretary to highlight certain points with respect to the AGM.

The facility of participation at the AGM through video conferencing or other audio/visual means was made available for 1000 members on first come first serve basis

The Company Secretary informed that all the statutory registers/documents were made available for inspection in electronic mode throughout the meeting, and the same were available on website of the Company www.orientalaromatics.com . It was further informed that the Company had provided the facility of e-voting during the AGM also. Members who had not exercised their right to vote through remote e-voting were entitled to vote during the meeting and 15 minutes after the conclusion of the AGM.

Thereafter, the Company Secretary handed over the proceedings to the Chairman. Mr. Dharmil A. Bodani, Chairman & Managing Director, briefed stakeholders on Oriental Aromatics' 70-year legacy, highlighting key achievements including the commissioning of new plants at Mahad and Vadodara, strong financial performance and the internalization of heritage camphor brands for improved efficiency. He emphasized the company's resilience in the face of global market challenges, the successful implementation of sustainability initiatives, and a strong focus on environmental and social governance (ESG). Looking ahead, he expressed optimism for continued growth and expansion, reinforced by disciplined capital management and a 10% dividend recommendation to shareholders.

Thereafter, Mr. Shyamal Bodani, Executive Director, outlined Oriental Aromatics' continued growth, highlighting strong performance with a 12.9% increase in production and 11% rise in operating income. He emphasized the successful commissioning of new plants in Vadodara and Mahad, expanding the company's capacity and profitability. Mr. Shyamal also discussed strategic focus areas such as market expansion, product innovation, and the rise of premiumization in India. He briefed about the company's commitment to community development through educational and social initiatives. Looking ahead, he expressed confidence in sustained growth, with increased exports and a diversified product portfolio driving future success.

Then, the Chairman proceeded with formal business of the meeting.

He informed that with the consent of the members present at the meeting, the Notice convening the Annual General Meeting, the Report of Board of Directors and the Accounts for the financial year ended 31st March, 2025 were taken as read. As there were no qualifications in the Audit Report, it was not required to be read.

III. Manner of Approval:

Thereafter, the Members who had registered themselves as speakers asked their queries. The queries of the Members were responded by Mr. Dharmil A. Bodani, Chairman & Managing Director, Mr. Parag Satoskar (CEO) and Mr. Girish Khandelwal (CFO) accordingly. The suggestions of the Members were taken on record.

Since all the business mentioned in the AGM notice was transacted, the Chairman declared the meeting as concluded. The Meeting concluded at 12:47 p.m. (including 15 minutes provided for e-voting).
