Sub: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015;

Pursuant to Regulation 30 read with Para A of Part A of Schedule III of the SEBI (LODR) Regulations, 2015, we wish to inform you that Olectra Greentech Limited ("Olectra"/ "Company") has received a demand notice from the "Telangana Industrial Infrastructure Corporation Limited (TGIIC)" imposing a penalty of Rs 2,57,87,484 (including GST) for the period from 12th November, 2023 to 11th November, 2025. The penalty is due to the delay in the full completion of the ongoing construction of the Greenfield EV Manufacturing Facility at the Industrial Park, Seetharampur, Hyderabad, Telangana.

Pursuant to the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI circular no. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated 13th July, 2023, the relevant details pertaining to notice of penalty are specified herein below.

4		In accordance with the sale agreement dated 11th November, 2021 between the Company and TGIIC ("Sale Agreement"), the Company acquired 150-acres of land at the Industrial Park, Seetharampur, Hyderabad, Telangana ("Scheduled Property"), for the purpose of setting up of "Greenfield EV Manufacturing Facility" ("Facility").
	Details of the violation(s)/contravention(s) committed or alleged to be committed	In response to the Company's request for an extension of the timelines for setting up the Facility and for issuance of the required No-Objection Certificate (NOC) to obtain credit facilities against the Scheduled Property, TGIIC invoked the penalty clause set out in the Sale Agreement and levied a penalty of Rs 2,57,87,484 (including GST) for the period from 12th November, 2023 to 11th November, 2025 for the delay in completing the construction of full factory. The Company, however, has already partially commenced commercial operations at the new facility within
		the timelines stipulated in the Sale Agreement.
5.	Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible.	Apart from the penalty amount, there is no material impact neither financially nor operationally.
