QJA/GR/CFID/CFID/30598/2024-25 dated July 30, 2024 (SEBI Order), against the Company, its Chairman and others in the matter of alleged misstatements/irregularities in financial statements of the Company, subject to deposit of penalty amount by the appellants. - An appeal was filed by the Company before Hon'ble Securities Appellate Tribunal (SAT) against the aforesaid impugned SEBI Order and Hon’ble SAT, vide its Order dated October 1, 2024 (SAT Order), has granted stay on direction at paragraphs No. 41 (1) and (2) of impugned SEBI Order, subject to deposit of penalty amount by the appellants. The Company had deposited the penalty, without prejudice to its rights. - On September 1, 2026, the Hon’ble Securities Appellate Tribunal pronounced the
