Pursuant to Regulation 30(6) read with Schedule III, Part A, Para A of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), we hereby inform you that the Company has received an order dated May 16, 2026 from the MSME Commissionerate, Gandhinagar, disposing the complaint filed by the Company against Chromeni Steels Private Limited under Section 18 of the Micro, Small and Medium Enterprises Development Act, 2006, pertaining to delayed payment amounting to Rs. 181.17 lakhs. The aforesaid amount comprises principal outstanding of Rs. 104.92 lakhs and interest thereon amounting to Rs. 76.25 lakhs. The financial impact of the said order shall be limited to the amount recoverable from Chromeni Steels Private Limited. This order shall not impact the operations or other activities of the Company.

The said order was delivered to the Company through post on May 26, 2026.
