Please find our point-wise response below:

1. Whether such negotiations/events were taking place? Reply:

Yes, Oriana Power Limited has signed a Memorandum of Understanding (MoU) with the Government of Rajasthan under the "Rising Rajasthan 2024" initiative to explore investment opportunities in renewable energy projects. These include solar power, floating solar, green hydrogen, and energy storage solutions, amounting to ₹10,000 crore.
